**DRAFT ORDINANCE ADDING ARTICLE 5 TO CHAPTER XIX OF THE  
LOS ANGELES MUNICIPAL CODE TO PROHIBIT THE DISTRIBUTION AND SALE  
OF EXPANDED POLYSTYRENE PRODUCTS COMMONLY REFERRED TO UNDER  
THE TRADE NAME STYROFOAM™**

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance would add Article 5 to Chapter XIX of the Los Angeles Municipal Code to prohibit the distribution and sale of expanded polystyrene products. Polystyrene, commonly referred to under the trade name Styrofoam™ is a thermoplastic resin made of styrene, a constituent of petroleum. Expanded polystyrene is formed when a blowing agent, such as pentane or isopentane, is added to polystyrene. Expanded polystyrene is a lightweight, thermal insulator, moisture-resistant, with high shock absorbency. These characteristics have led to its extensive use in the food and packaging industries.

This draft ordinance seeks to reduce expanded polystyrene products in the City to further its goals of reducing waste, increasing energy efficiency, promoting equity and environmental justice, addressing the impacts of climate change, and advancing a just transition toward more circular, equitable, and regenerative economies. This draft ordinance designates the Department of Public Works, Bureau of Sanitation (LASAN)

as the designated Administrative Agency with the authority to establish rules and procedures to aid in the administration and enforcement of this article.

California Environmental Quality Act (CEQA)

At the time of transmitting this report, environmental review is still pending with LASAN. Prior to or concurrent with adoption of the draft ordinance, the City Council can comply with CEQA by considering the CEQA clearance prepared and submitted by LASAN. As such, City Council may adopt the LASAN's CEQA determination and its findings, as applicable.

Council Rule 38 Referral

A copy of the draft ordinance was sent, pursuant to Council Rule 38, to the Department of Public Works, Bureau of Sanitation with a request that all comments, if any, be presented directly to the City Council when this matter is considered.
