At its meeting held on September 29, 2022, the Municipal Facilities Committee (MFC) approved the attached City Administrative Officer (CAO) report, which is hereby transmitted for Council consideration. Adoption of the report would authorize the approval of a Tiny Home Village on the Bureau of Sanitation (BOS) yard located at 850 North Mission Road and to authorize a portion of the BOS yard at 2212 Jesse Street (Mission and Jesse) to relocate the bins and operations currently located at the Mission site.

There is no additional General Fund impact in the current year, as funding budgeted for homeless services within the 2022-23 Additional Homeless Services - General City Purpose Fund (AHS-GCP) budget will be used to fund current annual leasing costs for Mission and Jesse (\$188,363). Funding to address \$493,924 in capital improvements required for the Mission and Jesse site will be funded by Council District 14's discretionary funds (\$300,000) and AHS-GCP monies (\$193,924).

Subject: **Report Back on Municipal Facilities Report for the Authority to Use 850 N. Mission Road for a Tiny Home Village and the Relocation of Solid Waste Bins to 2212 Jesse Street**

SUMMARY

On August 25, 2022, the Municipal Facilities Committee (MFC) considered a report, dated August 23, 2022, which requested authorization of a Tiny Home Village on the Bureau of Sanitation (BOS) yard located at 850 N. Mission Road and to authorize a portion of the BOS yard at 2212 Jesse Street (Mission and Jesse) to relocate the bins and operations currently at 850 N. Mission Road. The MFC approved recommendations 1, 2, 4, 5, and 8, and requested a report back clarifying Recommendation numbers 3, 6, and 7. This report provides clarification and amends the recommendations.

RECOMMENDATION

That the Municipal Facilities Committee recommend that the City Council:

1. Approve up to \$188,363 from Additional Homeless Services - General City Purpose Fund No. 100/56, Account No. 000931 to Citywide Leasing Fund No. 100/63, Account No. to be determined, entitled, "Leasing - Mission and Jesse in CD 14" for leasing costs of approximately 34,882 square feet of Bureau of Sanitation (BOS)-owned yard located at Mission and Jesse through June 30, 2023;
2. Approve \$493,924 to fund the capital improvements required to accommodate the BOS yard operations at the Mission and Jesse site;
3. Transfer \$300,000 from Fund No. 682/50 Account No. 50TVGZ, "Mission/Myers/Jesse Roundabout Project - AC Paving for LASAN Yard" to Fund 100/40, Account No. 003180, Construction Materials, for the capital improvements at Mission and Jesse;

4. Transfer \$193,924 from Additional Homeless Services - General City Purpose Fund No. 100/56, Account No. 000931 to Fund No. 100/40 to the following accounts for the capital improvements at Mission and Jesse:
 - a. \$46,211 to Account No. 001101, Hiring Hall Construction
 - b. \$19,831 to Account No. 001121, Benefits Hiring Hall Construction
 - c. \$127,882 to Account No. 003180, Construction Materials

5. AUTHORIZE the CAO to:
 - a. Prepare Controller instructions or make necessary technical adjustments, including to the names of the Special Fund accounts recommended for this report, to implement the intent of these transactions, and authorize the Controller to implement these instructions;
 - b. Prepare any additional Controller instructions to reimburse City Departments for their accrued labor, material or permit costs related to projects in this report, to implement the intent of these transactions, and authorize the Controller to implement these instructions; and
 - c. Make technical corrections, as necessary, to the transactions authorized through this report, as required to implement the intent of those transactions.

DISCUSSION

Recommendation 3: \$3 Million Municipal Improvement Corporation of Los Angeles (MICLA) Authority for Mission and Jesse – Revised to Recommendations 2-4

A new allocation of up to \$3 million of Municipal Improvement Corporation of Los Angeles (MICLA) funds was recommended to cover the following capital improvements required for the Mission & Jesse site: New asphalt, chain link fencing, wrought iron fencing, lighting, grading, drainage, creating a new entrance, and design for a new switchgear pad. The program management team was able to reduce the scope of work and identify significant savings. The new scope includes new asphalt, chain link fencing, and entrance relocation, for a new cost of \$493,924, as seen in Attachment 1. These improvements will be funded through Council District 14's discretionary fund allocation of \$300,000, provided in the motion approved on June 30, 2021 (De Leon - Rodriguez, CF 21-0563). The remaining balance of \$193,924 will be funded with the Additional Homeless Services - General City Purpose fund. The bins at Mission and Jesse will be relocated during its construction to allow construction to begin at the Tiny Home Village site, 850 N. Mission Road.

Recommendations 6 and 7: Mission and Jesse Leasing - Revised to Recommendation 1

The site located at 2212 Jesse Street, also known as Mission and Jesse, was purchased by the BOS using Sewer Construction Maintenance (SCM) funds. In doing so, a market rate lease is required to be paid to make the SCM fund whole. Since the bins that are currently located at 850

N. Mission Road are solid waste bins, the funds to SCM would typically be paid by the Solid Waste Resources Fund (SWRF). However, SWRF is currently subsidized by the General Fund, and therefore, the lease payment for Mission and Jesse is recommended to be paid with General Fund monies. Recommendation 7 in the Municipal Facilities Report dated August 23, 2022 has been revised in Recommendation 1 of this report. Since SCM and SWRF are both owned by BOS, an official lease agreement is not required, so Recommendation 6 in the same report is not necessary. However, BOS should take the necessary actions to document the use of the SCM property for a SWRF function, as well as the payments to SCM for SWRF related use.

FISCAL IMPACT STATEMENT

As SWRF is subsidized by the General Fund, the GF will need to continue funding the payment to SCM until such time as the General Fund subsidy for SWRF is resolved. Therefore, approval of the recommendations in this report will result in a \$188,363 annual impact to the General Fund.


