"For almost twenty years, Presiliano was a housing inspector in the Los Angeles Housing Department, retiring in 2018 as a Senior Housing Inspector. At LAHD, Presiliano was responsible for periodic and complaint-based inspections of multi-family rental housing and the enforcement of the Los Angeles Housing Code. He also supervised LAHD's Urgent Repair Program, Specialized Enforcement Unit, and Property Management Training Program, among other things. From 2002 through 2006, Presiliano was an instructor at a contractors' licensing school, teaching contractors in the building trades the essentials necessary to become a licensed contractor. Prior to that, from 1990 through 1999, Presiliano was a general contractor specializing in residential and commercial building construction. Presiliano is bilingual in Spanish and English.

Should this apply to your Commission, you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws, and a copy of the State Form 700/Statement of Economic Interests. You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission at 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012.
