

**AMENDMENT NO. 1 TO AGREEMENT NO. 47430
BETWEEN
THE LOS ANGELES DEPARTMENT OF WATER AND POWER
AND
SUPERHEAT FGH SERVICES, INC.**

THIS AMENDMENT NO. 1 to Agreement No. 47430 is made and entered into by and between the City of Los Angeles acting by and through the Los Angeles Department of Water and Power (LADWP), a municipal corporation, and Superheat FGH Services, Inc. (Consultant) a private corporation who are referred to under this Amendment as "Party" and collectively the "Parties."

WITNESSETH

WHEREAS, the Parties have entered into Agreement No. 47430 wherein Superheat FGH Services, Inc. agreed to provide welding preheat and postweld heat treatment services at the Power System generating stations and other LADWP facilities effective April 10, 2018, which together with all amendments and supplements thereto hereinafter shall be referred to as the "Agreement," and

WHEREAS, the Agreement sets the term of five years with two one-year extension options and a not-to-exceed amount of \$1,200,000 for total compensation that may be paid to the Consultant; and

WHEREAS, the Parties are amending the Agreement for the purpose of increasing the Agreement's not-to-exceed amount by \$2,000,000 from \$1,200,000 to \$3,200,000.

NOW, THEREFORE, the Parties hereby agree to amend Agreement No. 47430 as follows:

1. Section 4.1.1 Not-to Exceed Amount, currently reads:

"The total compensation that may be paid to the Consultant by LADWP for complete and satisfactory performance of services under this Agreement shall not exceed \$1,200,000."

is hereby amended as follows:

"The total compensation that may be paid to the Consultant by LADWP for complete and satisfactory performance of services under this Agreement shall not exceed \$3,200,000."

Except as amended herein, all terms and conditions of Agreement No. 47430 shall remain in full force and effect.

This Amendment No. 1 may be executed in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same amendment. The parties further agree that facsimile signatures or signatures scanned into .pdf (or signatures in another electronic format designated by LADWP) and sent by e-mail shall be deemed original signatures. This Amendment No. 1 consists of two (2) pages.




