SUBJECT: CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) NOTICE OF EXEMPTION (NOE) FOR ORGANIC WASTE COMPLIANCE ORDINANCE (COUNCIL FILE 21-1208)

Following the requirements of the California Environmental Quality Act (CEQA), the City of Los Angeles – LA Sanitation and the Environment has prepared a draft Notice of Exemption (NOE), attached thereto, based upon its environmental review of the proposed project: Organic Waste Compliance Ordinance (Council File 21-1208).

Staff recommends that the City Council make the following determination as its first recommended action before approving the project.

1. Determine that this project, which involves adopting an ordinance to regulate organic waste in the City, is exempt from CEQA under Section 15308 of the CEQA guidelines, and that no exceptions to the exemptions under CEQA Guidelines Section 15300.2 exist, including that no unusual circumstances exist that would cause a significant impact on the environment, as more fully described in the Notice of Exemption (NOE) submitted by LASAN in the Council File for action.
