The idea of the slow street sounded wonderful. But in reality, this slow street never worked. Every time we tried to use it we were challenged by car drivers. I was screamed at, spit upon and my children learned many colorful, new words spewed at us by drivers enraged by the fact that there were children on bikes in the street. I was left in tears more than once. Finally, another parent told me that the only way to make the slow street work was to pull the sandwich board signs into the middle of the intersection and get multiple adults standing at each side of the block to force drivers to slow down or take another route.
