# ADMINISTRATIVE CITATION ENFORCEMENT PROGRAM STATUS REPORT

Honorable Members:

On June 21, 2013, your Council adopted the Administrative Citation Enforcement (ACE) Program Ordinance (Council File 10-0085) and requested that the City Attorney's Office develop an ACE Pilot Program involving the Los Angeles Police Department (LAPD) and the Department of Animal Services (DAS). On November 5, 2014, the City Council adopted an implementation plan for the pilot program, and as part of that plan, requested that the City Attorney periodically report on the status of the program. This report provides the most recent update for the program and recommends the addition of the Los Angeles Sanitation and Environment Bureau to the ACE program (see attached request from the Chief Environmental Compliance Officer).

#### Recommendation

1. Approve the request of the City of Los Angeles Sanitation and Environment (LASAN)/Watershed Protection Division (WPD) Environmental Enforcement and Emergency Response Unit to participate in the ACE Program. A previous request for inclusion of LASAN in the ACE Program was listed in the 2018 – 2019 ACE Program annual report, but due to the COVID-19 pandemic, the request was continued indefinitely on 2/20/2020 by the Public Safety Committee. This latest request is a repeat of the former request.

2. Receive and file the Annual 2019 - 2020 Fiscal Year Status Report.

# Program Implementation

The ACE Pilot Program has been enthusiastically embraced by LAPD, Department of Animal Services (DAS), Department of Parks and Recreation's Park Rangers (Park Rangers), and the Bureau of Street Services (BOSS) enforcement personnel. The Home-Sharing Ordinance was adopted on December 11, 2018, and the regulations became effective on July 01, 2019. Los Angeles Housing and Community Investment Department (HCIDLA) and Los Angeles Department of Building and Safety (LADBS) began issuing citations in late February 2020 for advertising home-sharing without a City registration number.

The City Attorney's Office continues to review every citation issued and submitted for processing. To date, the Supervising Assistant City Attorney has reviewed approximately 52,000 citations. The City Attorney's Office also continues to participate in regularly scheduled LAPD, DAS, Park Rangers and BOSS trainings to strengthen the program and the collaboration between our offices.

### LAPD Statistics

From July 1, 2019, through June 30, 2020, LAPD issued 5,978 citations. Over 77% of those citations were processed; the remaining citations were either referred to another program for handling or rejected after being reviewed. The following is a summary of the citations received from each LAPD division between July 1, 2019, and June 30, 2020.

Of the LAPD citations processed in this reporting period of the ACE Program, offenses were recorded in the following general categories:

•	Possession of open container on or adjacent to ABC location	9.01%

During this reporting period, 360 violators cited by LAPD requested an initial review out of a total of 4,615 citations processed.

The City's ACE Ordinance allows violators an appeal by requesting an independent hearing which is conducted by an Administrative Hearing Officer. During this reporting period, 32 hearings were held for LAPD citations. Additionally, 42 LAPD citations were referred to the Homeless Engagement and Response Team (HEART) program and 4 LAPD citations were referred for criminal prosecution.

# Park Rangers Statistics

Park Rangers began issuing citations in July 2016. The following represents the status of citations received between July 1, 2019, and June 30, 2020:

# Payment of Fines and Transfer of Fines to Code Compliance Fund

The City's citation processing company, Data Ticket, collects fines and late penalties from persons who have been cited through the ACE Program and whose citations have been screened and referred for processing by the City Attorney's Office.

The 2019-2020 fiscal year total of collections was \$1,220,062.67 for the ACE Program. The fines and penalties collected by Data Ticket are electronically transferred to the Office of Finance monthly for deposit to the Code Compliance Fund, which was established in the ACE Ordinance.

Data Ticket invoices the City Attorney's Office monthly for its citation processing services, in accordance with its contract. During the 2019-2020 fiscal year, a total of \$165,137.56 was paid by the City to the contractor for processing, noticing, and collection services.

Unpaid citations are referred to the income tax return intercept program of the State's Franchise Tax Board. From July 1, 2019, through June 30, 2020, a total of \$95,244.19 has been deposited to the Code Compliance Fund from income tax refund intercepts by the Franchise Tax Board. As more cited persons become eligible for State income tax refunds, additional payments to the City are likely to be received.

# Unpaid Fines and Penalties

The total of unpaid fines from July 1, 2019, through June 30, 2020, was \$1,405,604.55. The breakdown by each of the participating departments is as follows:

- Los Angeles Police Department: \$795,370.18
- Department of Animal Services: \$264,778.88
- Department of Recreation and Parks: \$100,902.50
- Bureau of Street Services: \$82,375.00
- Los Angeles Department of Building and Safety (Home Sharing): \$124,377.99
- Housing and Community Investment Department (Home Sharing): \$37,800

## Expansion of the ACE Pilot Program

The City's ACE Ordinance allows for the expansion of the ACE Pilot Program to include additional City departments upon City Council approval. The request to participate from the LASAN (Los Angeles Sanitation and Environment Bureau) is attached.
