Alfred St., Los Angeles, CA 90035 November 14, 2022 Dear Members of the Los Angeles City Council; I URGE YOU TO VOTE YES on this resolution to extend 41.18 status to the Preuss Station United States Post Office at 1270 S. Alfred St. (at Pico Blvd.) in Los Angeles. I personally witnessed the danger by occupants of adjacent encampments to members of the public that use this vital public facility. There are few post offices left in this part of the city, and this one is large and heavily used by people from all over this area. Many walk to this facility, as well as drive to it. I live and own property just up the block from the post office. I witnessed the open use of drugs by members of the encampment that sprang up beginning July 4, 2022 on the public sidewalks adjacent to the post office's west, south and east building and parking lot. Sidewalks were obstructed by the occupants of the encampment despite repeated entreaties by members of the neighborhood, LAPD Wilshire Division Senior Lead Officers, and general public visitors to leave at least enough room for wheelchair bound citizens to pass, as well as pedestrians. These pleas were never responded to; in fact, the occupants only extended their belongings and even themselves farther into the public right of way. Worse, members of this encampment – despite repeated outreach efforts by city social workers, LAHSA, drug rehabilitation social workers, and even neighborhood rabbis – refused all assistance for housing, mental health services and drug rehab services. In fact, they defiantly and openly used drugs, with their drug paraphernalia in full view of passing families with children, and teens (there are two yeshivas close by). To sustain their drug use, they engaged in bicycle theft and "chop shop" business on the sidewalks. Suddenly, after they established their encampment, bicycle thefts and other petty theft skyrocketed in our neighborhood, and many residents reported finding members of this encampment prowling in their yards looking for items to steal. There were also many frightening encounters at night and as well as in the day, just going for walks in our once-peaceful neighborhood. One of the members of the encampment, a woman, also physically assaulted a postal employee. The LAPD has submitted all the required records of the arrest they made of this woman for the assault on the female post office worker. The

perpetrator was soon released by the municipal court, and she returned to the encampment. Once back in the encampment, she then physically assaulted two women in the South Carthay neighborhood (which adjoins the post office), punching one in the stomach for no reason. Other assaults, including throwing a brick at a woman were reported. With many Orthodox Jewish families using the sidewalks around the post office to walk to nearby synagogues to attend services, and scores of yeshiva boys, and boys and girls attending the private school one block from the post office, and other citizens of the city needing safe access of our public sidewalks to use the post office for important business, including mailing ballots in for voting, I URGE YOU TO VOTE IN FAVOR of this resolution. My family members and I normally walk to the USPS which is very convenient to us. We have been using our beloved post office for almost 15 years. From the USPS , we walk across the street to the Joanne's in the shopping center. All our neighbors use this post office and we cherish it in our beautiful neighborhood. In the past 6 months, we all learned that 4 people were assaulted by a homeless woman in the encampment that was initially living on Alfred Street at the post office. We also learned that when many more homeless people showed up, and squatted there for months, many neighbors had their family bikes stolen, amongst other items, and I watched a man ride down my block towards the post office with my neighbor's child's bike. This post office has been and is our neighborhood's unique treasure , we know the people that work there. Our kids go there to buy holiday stamps, to mail family birthday gifts, to send and receive mail, and many of us have begun our international journeys with a passport picture taken there It belongs to our community, as it should and it needs to be immediately protected .We have been unable to go there because the homeless encampment was directly in front of the parking lot and they were harassing customers and neighbors. I urge you to please protect this site and designate it as a sensitive location so it can be immediately protected, so our family neighborhood can be protected from further criminal activity, drug dealing , theft and violence against our neighbors caused by the homeless dwellers that do not want to be helped and are preying on us using this site as their base. Now, none of my neighbors , nor I feel safe to go there by foot, and we are all very afraid to go there even by car , because the recent violence and theft emanating from there has been terrifying. During the last year, I have grown afraid to go to the post office to mail a letter or pick up stamps. One of my neighbors was attacked just feet away from the post office when one of the unhoused people threw a Coke can at her forehead before running up to her and punching her in the stomach. She has not been to the post office since then. This post office has become a den for drug deals, public urination and defecation, other illegal activities. We have been intimidated and harassed well strolling our babies and walking our dogs. About six months ago I saw a woman emerge from a tent to walk down the street entirely naked. Well nearly naked: she was wearing flip-flops. Please restore safety to our neighborhood and designate the post office in South Carthay as a 41.18 consideration. I would like to be able to safely mail letters in my own community rather than go to an adjacent neighborhood to take care of my post office needs.
