It was unsafe to walk on the sidewalk or street near the encampment. I personally witnessed drug use and trafficking and defecating and urinating on the sidewalks and the street. One morning on my way to work, I noticed that a planter had been set alight. For several weeks, both sidewalks near the intersection of South La Jolla Ave. and Pico Blvd. were completely overtaken. Pedestrians had to use the street which is entirely unsafe especially given the large number of families with young children who live in the area. There have been multiple thefts of lawn and patio furniture as well. These encampments create an unsafe and unhealthy environment for both the local residents and the unhoused themselves. Hi, Officer Green.


My name is Liz Fonseca. I live a few doors down from CVS. On Sun 7/24 around 10 AM, while loading my car, this woman attacked me by throwing a rock the size of a baseball at me from only a few feet away. We called 911 but couldn't wait for the cops to show. Then around 5 PM she went into our backyard, was throwing bricks, and stole mats. 911 was called by my sister in law who lived in the duplex downstairs (we live upstairs). The police returned the mats and stated that they will contain her until a psych eval. On Tues 7/26, my next door neighbor sent a picture of her sleeping in front of their house. I left a message on the non-emergency line with the police. We were never notified that she was released.


Last night I read on Nextdoor that there were two separate attacks on Alfred St- both women were Asian and both women were minding their own business. One was at the post office. The other was near Auto Zone. The woman somehow got away on foot by crossing Pico. This woman is very dangerous and has violent tendencies. In my case and the other two women, we were not able to protect ourselves since this was an unprovoked attack. My husband saw her last night 7/31 walking past our house!

I went to the police station today, 8/1 to make an official report for the 7/25 incident and they stated I couldn't. I wanted to file a restraining order to keep my family safe. However they stated I needed her info and to file DTLA. They told me that you might know her or is already aware of the situation. If you do know her, can you please provide me with her info?

I am extremely worried about my parents (in their late 60s) who are currently visiting and are not being able to protect themselves. I have little toddlers (ages 2-4) as well. I do not feel safe anymore especially seeing that the past attacks were on Asian women.

If you can help with anything, please let me know.
