

I'm writing in support of designating 911 Formosa under 41.18. The history of people camping around the DWP, especially on the Poinsettia side across from the park, goes back for year even before most Angelenos grasped the problem. That first year someone was stabbed. Since we moved into the house right next to the DWP on Poinsettia we have had people almost constantly camped starting within feet from out driveway and garage starting in 2018 and it several escalated in 2020. The trash that piles up has made the side walk beyond ever truly getting clean, even with Care plus. We have found heroin needles, clothing soiled with urine and feces thrown over our fence or placed in front of our doors. We have found people sneaking into our gates driveway to do drugs out public view. They have started trash fires, and tents have burned. People in expensive vehicles come hang out with them at odd hours of the night playing music. I can hear them speaking and sometimes ranting to themselves from my bedroom in the front of the house at night. We have had mentally unstable people lunge at us screaming only to back away when our two large dogs became aggressive to let them know not to approach. We discuss this on Neighbor and at the park across the street when our dogs play. The entire surrounding neighborhood is effected and everyone fears for their safety. Mostly people won't even walk near the park after dark anymore. Please make out neighborhood safer but getting people off the street where we live.

A man was struck by a car because of this. I've seen elderly in wheelchairs and children forced to resort to a busy street to avoid their encampments. They have started fires, assaulted numerous people and one woman trashed 5 backyards, terrorizing tenants on Orlando which resulted in a mob of tenants chasing her to Pico. Yet they continually come onto private property, my own included. During the recent Care Plus cleanup we discovered that they tapped into the electricity of the street light near the parking garage on La Jolla Ave. Very dangerous! Poinsettia Park: I live near the park and have so for almost 10 years. A few ago we had about 20 tents in that area, with more than 20 unhoused persons. In that time, it was not safe to walk up Poinsettia after dark. I would Uber to a restaurant 4 blocks away to ensure my safety. One of the things that exasperated the issue was an empty duplex next to my building. Forget about the prostitution and drugs done in that house and the stabbing that occurred, the house was set fire to 3xs. This duplex was 15 feet from my back window. My neighbors and I were so worried we called and texted each other constantly. We even would meet someone at the gate, walk their dog with them or jump in the car with them if they couldn't find a spot close. Then it Al calmed down. The tents were gone. Unfortunately, the tents are starting to fill up the street again. We can't allow unhoused people to be in an unsafe situation. We must find a solution that's a plus for them -with showers and a regular needle exchange. A place they can close their eyes and not worry about what will happen in the middle of the night. By helping the unhoused, we also keep the street safe for the residents. We must think of everyone. The tents are not a safe solution for anyone. Comments for Public Posting: Every day, I wake up and walk my dog to Poinsettia Park. Most mornings I am forced to look at several people, often in various states of undress, sleeping in the park, surrounded by garbage, drug paraphernalia or items stolen from my neighbors during the night. I come home, eat breakfast, and drive to work. Every day, at the first light I reach, on the intersection of Willoughby and La Brea, I see a row of dilapidated tents taking up the entire sidewalk so no pedestrians can get by. There are desk chairs and stolen bicycles, broken furniture and plastic bottles filled with urine. The amount of garbage on this corner is almost unfathomable, and it spills out on to the street. The public sidewalks have been completely taken over, so that no one may use them. This is my view every morning before 8 AM. The unfortunate people living in these tents are usually up and meandering dangerously through the traffic, often yelling at the drivers or to no one in particular. This morning the risk of hitting someone was low, as the three inhabitants were all sitting on a parasite-infested couch, smoking what appeared to be crystal meth. A couple months ago, a woman was shot in the face coming out of the Sprouts grocery store on the other side of the street. Nothing was done, no arrests were made, and the problem still remains. Earlier this year, a beautiful 24-year-old woman was killed while working at a furniture store on the same street. And nearly every night I am awakened by the sound of police helicopters hovering over the neighborhood I call home. With all this violence, my wife no longer feels safe walking our dog outside in the evenings, as there are too many drugged out or dangerous people roaming the neighborhood, looking for targets. It has become increasingly dangerous to walk our dog, go to work and shop at the grocery store. I know this is an extremely difficult problem and I certainly don't envy the responsibility you and your colleagues have in solving it. I also realize there must be sympathy and services for those afflicted with addiction issues or mental illness. But this city and its leaders need to do more to protect its law-abiding and tax-paying citizens. Those in power seem to have confused progressiveness with permissiveness, and we are quickly losing control of the streets as a result. There is a deep feeling of sadness that the rule of law has been broken in our neighborhood. The good people of West Hollywood are looking on with despair. We pay far too much in taxes to live in and

amongst this type of wretched, stomach-churning depravity and filth. The problem has gotten so bad that I am now considering moving out of this city that I love. That said, if there's anything tangible an average citizen can do to help, without putting my own health and safety at risk, I will be more than happy to volunteer.
