

THIRD AMENDMENT TO AGREEMENT NO. 19-3675  
BETWEEN THE CITY OF LOS ANGELES AND  
ALVARADOSMITH PC

This THIRD Amendment to Agreement No.19-3675 is made and entered into by and between the City of Los Angeles ("City"), a municipal corporation, acting through its Board of Harbor Commissioners ("Board") and the Office of the City Attorney ("City Attorney"), and AlvaradoSmith PC ("Outside Counsel").

WHEREAS, the City entered into Agreement No. 19-3675 with AlvaradoSmith PC, for professional legal services for real estate matters, litigation support, eminent domain and inverse condemnation; and

WHEREAS, additional legal services were necessary for liability litigation defense counsel to handle claims and litigation arising out of auto accidents, as well as other liability claims ; and

WHEREAS, the term of the Agreement commenced on September 18, 2019 and would have terminated on September 17, 2022; and

WHEREAS, extending the term of the Agreement is necessary due to the need for additional legal services, and allows AlvaradoSmith to continue to assist the City Attorney with litigation support for *Juan Solorio v. City of Los Angeles 21STCV38128 C22-00676 (C-1937)*; and

WHEREAS, the City desires to extend the term of the Agreement from three years to six years.

NOW, THEREFORE, the parties agree that:

1. Section II (A) Period of Performance is replaced by the following:

"This Agreement shall begin on the date it is executed by the Executive Director, and shall continue for six (6) years thereafter, unless terminated earlier under the provisions of this Agreement. Due to the need for Outside Counsel's services to be provided expeditiously, Outside Counsel may have provided services prior to the execution of this Second Amendment. To the extent that Outside Counsel's services were performed in accordance with the terms and conditions of the Agreement, those services are hereby ratified."

Except as provided herein, all other terms and conditions of Agreement No.19-3675 shall remain the same.
