Carthay neighborhood. Since June of 2022, we have been dealing with encampments overtaking the intersections of South La Jolla Ave and Pico Blvd. This situation was only made worse by the encampment that started in July in front of the Preuss Station US Post Office at 1270 South Alfred Street. The encampment at Preuss Station drew more unhoused individuals to our neighborhood. It became a meeting spot for a bike chop shop and other activities. Members of the encampment pose a danger to traffic turning onto S La Jolla as they stopped in the middle of the street and crossed in front of cars with no regard for safety. Several individuals from this camp are/were aggressive and posed a threat to the safety of our community. My family and I no longer feel safe walking to local businesses on Pico Blvd. We have been forced to take alternative routes to avoid the individuals in the encampments. For months my security cameras have caught several homeless individuals trespassing past my front door and going to the garage area of my building and the neighboring buildings in the middle of the day and late hours of the night. We have had several scary situations over the past months. In one instance, a homeless woman armed with a knife trespassed onto our property and threatened a resident. In another instance, an aggressive woman from the Preuss Station encampment, who had previously attacked two women and had been arrested for assaulting a postal worker, went on a 3-hour rampage destroying property on the 1200 block of South Orlando Ave. In yet another incident, a neighbor was chased by an aggressive individual from the Preuss Station encampment when she was returning home from work. I urge you to please vote YES to help ensure our neighborhood is safe once again. Thank you.
