RESOLUTION

Resolution requesting the Los Angeles County Registrar-Recorder/County Clerk to conduct the City's Special Election and Special Runoff Election to fill the vacancy in the Sixth District of the Los Angeles City Council.

WHEREAS, the Council of the City of Los Angeles has called a Special Election to be held on Tuesday, April 4, 2023, and a Special Runoff Election to be held, if necessary, on Tuesday, June 27, 2023, for the purpose of filling the vacancy in the Sixth District of the Los Angeles City Council; and

WHEREAS, the City Council has authorized and wishes to request that the Los Angeles County Registrar-Recorder/County Clerk administer certain aspects of the Special Election and Special Runoff Election.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The City Council respectfully requests the Board of Supervisors of the County of Los Angeles to direct the Los Angeles County Registrar-Recorder/County Clerk to conduct all aspects of the Special Election and Special Runoff Election as provided by law for the conduct of elections administered by the County, except that the City Clerk shall administer the qualification and nomination of candidates for the Special Election and Special Runoff Election as provided in the City's Ordinance calling the elections.

- Sec. 2. The City Council requests the Board of Supervisors to fix the costs to be paid by the City of Los Angeles for the conduct of the Special Election and Special Runoff Election. The City of Los Angeles will reimburse the County of Los Angeles for the City's share of the costs incurred in conducting the Special Election and Special Runoff Election, if necessary, consistent with the cost estimate provided by the Registrar-Recorder/County Clerk and agreed to between the County and the City.
- Sec. 3. The Board of Supervisors is hereby authorized to canvass the returns of the Special Election and Special Runoff Election.
- Sec. 4. The Special Election and Special Runoff Election shall be held and conducted as provided by law for the conduct of elections administered by the Registrar-Recorder/County Clerk except as provided in the Ordinance calling the Special Election and Special Runoff Elections and as otherwise provided by applicable law.
- Sec. 5. The City Clerk shall file a duly certified copy of this Resolution forthwith with the Board of Supervisors and with the Registrar-Recorder of the County of Los Angeles.
