DISCUSSION:

The preliminary map of Parcel Map L.A. No. 2014-2579 was conditionally approved by the Advisory Agency on September 20, 2016 for one (1) lot.

The City Council adopted Mitigated Negative Declaration ENV-2014-2580-MND as the environmental clearance and has determined that this project will not have a significant effect on the environment provided that the potential impacts identified are mitigated to a less than

significant level through implementation of the Parcel's Conditions of Approval.

This final map proposes to merge the vacation and existing and future alley within the remainder of the subdivision pursuant to Section 66499.20.2 of the State Government code.

The conditions of approval for the parcel map have been fulfilled. Transmitted Subdivision Improvement Agreement and Contract with attached security documents guarantees construction of the required improvements. Upon approval by the Council, the final map will be transmitted to the County Engineer for filing with the County Recorder.
