PUBLIC WORKS COMMITTEE REPORT relative to declaring two properties owned by the City on Flower Street between Hope Street and Second Street, and the other bound by General Thaddeus Kosciuszko Way, Flower Street, Hope Street, and Third Street, as exempt surplus land.

Recommendations for Council action:

1. DECLARE two properties owned by the City, currently being used as public right-of-way; one located on Flower Street between Hope Street and Second Street (Parcel "A"), and the other bound by General Thaddeus Kosciuszko Way, Flower Street, Hope Street, and Third Street (Parcel "B"), which are also described in Exhibit A (Transmittal Nos. 1 and 2) and depicted in Exhibit B (Transmittal Nos. 3 and 4) of the Bureau of Engineering (BOE) report dated January 27, 2022, attached to the Council file, as "exempt surplus land" in order to satisfy certain relevant requirements of the new State law promulgated through Assembly Bill 1486.
2. INSTRUCT the BOE to prepare the sale ordinance to effectuate the City's sale of Parcels "A" and "B" to the Los Angeles County Metropolitan Transportation Authority (Metro), subject to City Attorney review and approval.

Fiscal Impact Statement: The BOE reports that there is no negative fiscal impact. The said BOE report only seeks the Council's approval to declare Parcels "A" and "B" as exempt surplus land. Upon the Council's approval and California Department of Housing and Community Development concurrence, the City will receive fair market value compensation from Metro on the sale of Parcels "A" and "B".

Community Impact Statement: None submitted

SUMMARY

On February 9, 2022, your Public Works Committee considered a BOE report relative to declaring two properties owned by the City on Flower Street between Hope Street and Second Street, and the other bound by General Thaddeus Kosciuszko Way, Flower Street, Hope Street, and Third Street, as exempt surplus land in order to satisfy requirements of the new State law promulgated through Assembly Bill 1486.

COUNCIL FILE 21-0561 REQUEST FOR “EXEMPT SURPLUS LAND” DECLARATION OF TWO PROPERTIES OWNED BY THE CITY OF LOS ANGELES IN COMPLIANCE WITH STATE LAW

Dear Honorable Council Members:

RECOMMENDATIONS

1. DECLARE two properties owned by the City of Los Angeles, currently being used as public right-of-way; one located on Flower Street between Hope Street and Second Street (Parcel “A”), and the other bound by General Thaddeus Kosciuszko Way, Flower Street, Hope Street, and Third Street (Parcel “B”), which are also described in Exhibit A (Transmittal Nos. 1 and 2) and depicted in Exhibit B (Transmittal Nos. 3 and 4), as “exempt surplus land” in order to satisfy certain relevant requirements of the new State law promulgated through Assembly Bill (AB) 1486.
2. INSTRUCT the Bureau of Engineering to prepare the sale ordinance to effectuate the City’s sale of Parcels “A” and “B” to the Los Angeles County Metropolitan Transportation Authority, subject to the City Attorney’s review and approval.

BACKGROUND AND DISCUSSION

The Los Angeles County Metropolitan Transportation Authority (Metro) is currently constructing the Regional Connector Transit Corridor Project (Project) in downtown Los Angeles. This Project is a 1.9-mile underground light rail transit line that will extend from the Gold Line Little Tokyo Station to the 7th Street Metro Center. The Project is scheduled to be completed in 2022.



In order for Metro to complete the construction of the Grand Av Arts/Bunker Hill Station, Metro needs to acquire two parcels of land owned by the City of Los Angeles (City). The two parcels of land consist of:

Parcel	Address/Location	Lot Size	Council District No.
A	Flower Street between Hope Street and Second Street	15,611 sq. ft.	14
B	General Thaddeus Kosciuszko Way, Flower Street, Hope Street, and Third Street	15,843 sq. ft.	14

Parcel “A” located on Flower Street, between Hope Street and Second Street, is currently used as a public right-of-way. Metro will use this parcel for the Grand Ave Arts/Bunker Hill Station Plaza.

Parcel “B” bound by General Thaddeus Kosciuszko Way, Flower Street, Hope Street, and Third Street is also a public right-of-way. Metro will use this parcel to install an emergency exit hatch, an equipment access shaft, a ventilation shaft for the Grand Av Arts/Bunker Hill Station, and to plant trees and landscaping for the Project.

To process the sale and transfer of Parcels “A” and “B” to Metro, as directed and authorized by City Council Motion (Council File No. 21-0561) (Transmittal No. 5), the Council must first declare the subject properties as “exempt surplus land” per AB 1486.

On January 1, 2020, AB 1486 took effect and amended the process for disposing of surplus land. Among other changes, AB 1486 requires that *“land shall be declared either ‘surplus land’ or ‘exempt surplus land,’ as supported by written findings, before a local agency may take any action to dispose of it consistent with an agency’s policies or procedures.”*

Upon approval by the Council, the Bureau of Engineering (BOE) will submit the request to the California Department of Housing and Community Development (HCD) to get concurrence with the City’s findings. Once the BOE receives concurrence from HCD, the BOE and the City Attorney’s Office will move forward with the sale and transfer of the properties to Metro.

FINDINGS

The City of Los Angeles finds that Parcels “A” and “B” are not needed for any City purpose. Furthermore, since the subject properties will be transferred *“to another local, state, or federal agency for the agency’s use,”* these properties are “exempt surplus land” as per AB 1486.

FISCAL IMPACT

There is no negative fiscal impact. This report only seeks the Council's approval to declare Parcels "A" and "B" as exempt surplus land. Upon the Council's approval and HCD concurrence, the City will receive fair market value compensation from Metro on the sale of Parcels "A" and "B".





The Los Angeles County Metropolitan Transportation Authority (Metro) is currently constructing the Regional Connector Transit Corridor Project in downtown Los Angeles. This Project is a 1.9-mile underground light rail transit line that will extend from the Gold Line Little Tokyo Station to the 7th St. Metro Center. 


