

ORDINANCE NO. _____

An ordinance amending Schedule “A” of Section 4.61 of the Los Angeles Administrative Code to provide salary adjustments for the non-represented classifications in the Office of the City Administrative Officer of Assistant City Administrative Officer, Chief Administrative Analyst, and Senior Labor Relations Specialist I-III.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Schedule “A” of Section 4.61 of the Los Angeles Administrative Code is amended to provide revised salaries for the classifications of Assistant City Administrative Officer, Chief Administrative Analyst, and Senior Labor Relations Specialist I-III, as follows:


Sec. 6. Section 5 shall be operative on June 18, 2023.

Sec. 7. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 8. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
