I moved to this neighborhood in 2018 knowing I was moving next to an airport. What I didn't know is that in doing so I would see an exponential increase in air traffic at all hours. We now have to sleep with a white noise machine on full blast and we still get woken up by jets from 11pm to 6am. The noise isn't even my biggest concern. The biggest concern are the jets that idle their engines and blast exhaust through our neighborhood all the time. It is so bad we are often forced back inside. We bought our home for the large backyard. A backyard we can no longer safely use because it is a health hazard! I often have to put on a mask while I walk my dogs. More recently I have been driving my dogs away from my neighborhood to walk them because the exhaust is so strong I worry about what it is doing to their health as well. We run air filters day and night in our house to try and keep our air clean. It's depressing that we can never enjoy the fresh air outside of our homes. Please think about how you would feel if your family lived here. My 93 year old neighbor is depressed over how air traffic has exploded since she built her home in the 50s. She too cannot get a decent nights sleep and this breaks my heart. Please help us. We have no one else advocating for our rights to healthy air and a curfew that limits noise pollution at night.

Comments for Public Posting: My husband and I have lived across the street from the Van Nuys Airport for over 27 years. With the closing of Santa Monica Airport we have seen an increase of charter flights where there is no TSA screening and there could be contraband and/or other items that would not get by regular airports/TSA. We have a moratorium regarding adding any new aircraft to VNY, yet a bill goes through that allows additional helicopters access despite this moratorium was passed! Our neighborhood is in need of respite, please help us!!! We have brought these issues to the FAA regarding all charter flights - with the average of a flying aircraft/helicopters leaving the airport at an average of one flight every eight (8) minutes. This is 24/7 for us. Now this new contract passed without public input adding additional aircraft to an already overcrowded airport, affectively bombarding a neighborhood that has their sleep interrupted, air quality issues with both the jet fuel (it is horrendous) and/or jet exhaust and noise issues. We are not compensated for obtaining dual paned windows and doors (most of the houses were built in 1951), nor are we heard when we file complaints on the Complaint Line at the Airport. We are drowning already and, after a moratorium of adding no new aircraft to VNY, a bill goes through that allows additional helicopters access despite this moratorium was passed! Our neighborhood is in need of respite, please help us!!!!!!
