Subject: **FIFTH AND SIXTH AMENDMENTS TO CONTRACT NO. C-129255 BETWEEN THE LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY AND THE LOS ANGELES POLICE DEPARTMENT**

RECOMMENDATIONS

That the Council, subject to the approval of the Mayor:

1. Authorize the Chief of Police, or designee, to execute the Fifth Amendment to Contract No. C-129255 with the Los Angeles County Metropolitan Transportation Authority (LACMTA) that replaces Exhibit A – Statement of Work with an updated version dated January 1, 2022;
2. Authorize the Chief of Police, or designee, to execute the Sixth Amendment to Contract No. C-129255 with the LACMTA that extends the term by six months from June 30, 2022 to December 31, 2022, and increases the contract budget by \$54 million from \$429,485,297 to \$483,485,497; and,
3. Authorize the Los Angeles Police Department to prepare Controller instructions for any technical adjustments, as necessary, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions.

SUMMARY

At its meeting on November 8, 2022, the Board of Police Commissioners (Board) approved a proposed Fifth Amendment to Contract No. C-129255 between the Los Angeles Police Department (Department) and the Los Angeles County Metropolitan Transportation Authority (LACMTA). The proposed Fifth Amendment will replace Exhibit A – Statement of Work in its entirety and substitute with a revised version dated January 1, 2022 that includes changes to the specific responsibilities

such as a plan to ensure effective law enforcement presence, body-worn camera deployment, and management and administrative duties of personnel.

On November 8, 2022, the Board approved the Sixth Amendment to extend the term by six months through December 31, 2022 and increase the contract budget by \$54 million from \$429,485,497 to \$483,485,497. The proposed Sixth Amendment also incorporates a non-disparagement clause as required by LACMTA, whereas Department staff shall not publicly disparage, denigrate or otherwise negatively characterize the LACMTA.

Background

On May 3, 2017, the Council authorized the Department to execute a five-year contract with the LACMTA to provide law enforcement services for the transit system's infrastructure, bus, and rail lines (C.F. 16-0358). The term of the agreement began on July 1, 2017 and expired on June 30, 2022, with a maximum allowable compensation of \$369,330,499. On June 29, 2018, the Council approved the First Amendment to Contract No. C-129255 that modified Section GC-14-A Termination for Convenience clause from six months to 12 months, which states that either party may terminate the agreement without cause by written notice sent at least 12 months prior to the termination (C.F. 18-0600-S116). This amendment also included budgetary adjustments and service enhancements to address understaffing and expanded hours, added a full-time K-9 Bomb Unit, and modified the dedicated Homeless Outreach and Proactive Engagement team from an overtime basis to 11 full-time officers. On September 29, 2021, the Council approved the Second Amendment with the LACMTA to increase the maximum allowable compensation by \$21,526,518 from \$369,330,499 to \$390,857,017. On June 15, 2022, the Council approved the Third Amendment to increase the maximum allowable compensation by \$38,628,480 from \$390,857,017 to \$429,485,497 and the Fourth Amendment that incorporates language requiring employees to comply with an enforced COVID-19 vaccine mandate.

In accordance with Los Angeles Administrative Code Section 10.5(b)2, Council approval of the proposed amendments are required because Council approved the original agreement and subsequent amendments.

FISCAL IMPACT STATEMENT

Approval of the recommendations stated in this report will authorize the Los Angeles Police Department (Department) to execute the Fifth Amendment to Contract No. C-129255 with the Los Angeles County Metropolitan Transportation Authority (LACMTA) to revise Exhibit A – Statement of Work. In addition, the recommendations authorize the Department to execute a Sixth Amendment with the LACMTA to extend the term by six months through December 31, 2022 and increase the contract budget by \$54 million to \$483,485,497. The proposed Sixth Amendment also incorporates a non-disparagement clause, as required by LACMTA. All other terms remain the same. Reimbursement for services provided will be deposited into Revenue Source Code 4603, Service to LACMTA. There is no additional impact to the General Fund.

FINANCIAL POLICIES STATEMENT

The recommendations stated in this report are in compliance with the City's Financial Policies in that the City will be reimbursed for services provided, based on the full cost of operations.



FOR: TRANSIT LAW ENFORCEMENT SERVICES

This Contract Modification No. 6 to Contract No. PS5862100LAPD24750 effective June 30, 2022, by and between the LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY, hereinafter referred to as "METRO", and the City of Los Angeles, a municipal corporation acting by and through its Police Department (LAPD), hereinafter referred to as the "CONTRACTOR."

WHEREAS, Contractor and Metro entered into Contract No. PS5862100LAPD24750, effective March 1, 2017, subsequently modified by Modification No. 1, effective July 1, 2018, Modification No. 2 effective August 16, 2021, Modification No. 3 effective January 1, 2022, Modification No. 4 effective July 1, 2022, and Modification No. 5 effective January 1, 2022, hereinafter referred to as the "Existing Contract" and;

WHEREAS, Contractor and METRO desire to amend the Existing Contract as provided herein;

Now, therefore, it is mutually agreed, by and between the parties, as follows:

1. ARTICLE IV.A – CONTRACT PRICE

The not-to-exceed Contract Price of \$429,485,497 shall be increased by \$54,000,000 for a revised not-to-exceed total Contract Price of \$483,485,497.

2. ARTICLE V: CONTRACT TERM AND PERIOD OF PERFORMANCE

Extend the term of the Contract by six (6) months to cover the period July 1, 2022, through December 31, 2022, and change the total Period of Performance to read, March 23, 2017, through December 31, 2022.

3. SP-05 - NON-DISPARAGEMENT

Contractor shall not publicly disparage, denigrate or otherwise negatively characterize the reputation, operations, or administration of LACMTA, including its officers, directors, managers, members, shareholders, partners, owners, employees, agents, successors and assigns. In the event the Contractor breaches this provision, LACMTA reserves the right to terminate this Contract for default; provided, however, that prior to LACMTA taking any action in furtherance of terminating the Contractor due to Contractor's alleged breach of this provision, representatives of LACMTA and Contractor shall first meet to discuss in good faith the alleged breach and agree on mitigating actions that Contractor may take to cure the alleged breach to LACMTA's approval, which approval LACMTA shall not unreasonably withhold.

All other terms and conditions of Contract No. PS5862100LAPD24750 shall remain unchanged.

Except as expressly modified hereby, the Existing Contract, as modified remains in full force and effect as originally executed.
