This item is to approve the Sustainable Communities Environmental Assessment (SCEA) for the future consideration of the development of the project identified as Planning Case Number: **CPC-2019-2567-GPAJ-VZCJ-HD-CUB-SPR**. Public Resources Code (PRC) Section 21155.2 requires the City Council to adopt findings and the SCEA prior to project approval if the City Council is not the decision-maker on the project approvals.

Planning has reviewed and circulated the SCEA as required by law and is now recommending that the City Council consider and adopt the SCEA (ENV-2019-2568-SCEA).

The SCEA (ENV-2019-2568-SCEA) determined that all potentially significant environmental impacts can be mitigated to less than significant levels. Mitigation measures were adopted for the following impact areas: Cultural Resources (archeological resources), Geology and Soils (paleontological resources), Noise (construction noise), and Tribal Cultural Resources (tribal archeological resources). The Project site is not included on the lists enumerated under Gov. Code Section 65962.5. Pursuant to PRC Section 21155.2, this SCEA: 1) incorporates all feasible mitigation measures, performance standards, or criteria set forth in the prior applicable environmental impact reports, including the Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS) prepared by the Southern California Association of Governments (SCAG), and adopted in findings made pursuant to Section 21081; and 2) contains mitigation that either

avoids or mitigates to a level of insignificance all potentially significant or significant effects of the Project required to be identified in the initial study prepared for the Project.
