DISCUSSION:

On October 28, 2022, under Council File No. 22-0517, the City Council per motion (Blumenfield-Krekorian), instructed the City Engineer to perform the necessary steps to change the name of Linnet Street between Crebs Avenue and Yolanda Avenue as shown colored red on the attached Exhibit "A", and establish it as Bill Lambert Way.

The motion states, "It is appropriate that the portion of Linnet Street that runs the length of Gaspar de Portola Middle School in Tarzana, where Mr. Lambert resides, be legally renamed as Bill Lambert Way."

A total of eight abutting property owners were notified of the proposal for the name change from Linnet Street to Bill Lambert Way. No responses were received from six abutting owners and two abutting owners opposed.

Upon adoption of the Ordinance by the City Council, the adjoining property owners and concerned agencies will be notified of the street name change.
