RECOMMENDATION APPROVAL (CF NO. 11-0937)

Recommendation

The Information Technology Agency (ITA) has reviewed the renewal application of the Young Women's Christian Association (YWCA) of Greater Los Angeles private line telecommunications franchise, granted in 2011 by City Council and Mayor, and recommends approval of said application request. Because private line franchises are effectuated by ordinance, ITA also recommends Council to request that the City Attorney prepare and present a draft ordinance to City Council, with a ten-year term, allowing for the renewal of this franchise.

Background

A private line telecommunications facility is an encroachment permit that provides for the interconnection between two points in the public rights-of-way, utilized solely for signal transmission and not to serve any customer within the City.

In 2011 the City Council and Mayor granted a 10-year telecommunications franchise to YWCA of Greater Los Angeles for the placement of conduit in the City's public rights-of-way between 1020 South Olive Street and 1031 South Hill Street. (See CF No. 11-0937 and Los Angeles City Ordinance No. 187771.)

YWCA of Greater Los Angeles is now requesting approval to renew said private line franchise for another 10 years.

Fiscal Impact

Approval of the renewal of this private line telecommunications franchise will generate \$2,500 in application fees and \$200 in annual franchise fees over the next 10 years for a total of \$2,000 during the ten-year term of the franchise.
