Comments for Public Posting: Item 21-0921 – Mandatory Vaccination Ordinance (Ordinance No. 187134) On August 11, 2022, the CDC updated their COVID-19 guidance policies. Its recommendations for unvaccinated individuals were brought into line with the vaccinated. This was an acknowledgment by the CDC that the unvaccinated should not be differentiated and discriminated against. They recognized natural immunity provides protection against COVID-19 and that individuals need to conduct their own risk assessments. Why hasn't the City of Los Angeles implemented this guidance in their policies? A number of local Southern California agencies have either completely rescinded their COVID-19 vaccine mandates for employees or dropped all testing requirements. Last month, the City of San Diego council members voted to repeal its vaccine mandate. Caltrans, which had a vaccine or test policy, dropped their testing policies for the unvaccinated on September 17, 2022. At this point, it is known that the vaccines do not prevent transmission and that COVID-19 can pass between individuals regardless of vaccination status. The City of Los Angeles's COVID 19 policies are discriminatory and outdated. Ordinance 187134 must be rescinded, and the testing policies abolished.

Comments for Public Posting: In re Agenda Item 3, the resolution relative to updating the Mandatory Vaccination Ordinance (Ordinance No. 187134) and implementation procedures, the resolution as currently written is untenable. The second clause allowing for reinstitution of surveillance testing of the unvaccinated in the event of an uptick in COVID-19 infections needs to be eliminated. A clause needs to be added completely rescinding all vaccination, masking, and testing mandates and legislating that the city will henceforth respect the constitutionally guaranteed right of all its employees to medical privacy. Now-former Director of the National Institute of Allergy and Infectious Diseases Anthony Fauci admitted to Ayman Mohyeldin in a December 29, 2021 appearance on The Rachel Maddow show, "...although a PCR is good to tell you, am I infected...the very fact that it's positive for, as the CDC director said, for several days and even weeks later, it doesn't give you any indication of whether or not you're transmissible. And I think that's the understandable confusion that people have about testing. Ergo, it has always been pseudoscientific to mandate their use for anyone, vaccinated or otherwise. Additionally, none of the COVID-19 tests, and none of the COVID-19 vaccines currently available in the U.S., have FDA approval. Pfizer BioNTech's Comirnaty and Moderna's Spikevax COVID-19 vaccines do have FDA approval on paper but are not available for administration anywhere in the U.S. Therefore, all of the mandated COVID-19 medical products referenced herein are Emergency Use Authorization (EUA) medical products. 21 U.S.C. Section 360bbb-3(e)(1)(A)(ii)(III) codifies a right of refusal to all EUA medical products. EUA medical products therefore cannot be mandated.
