Re: Office of Justice Programs (OJP): Community-Based Violence Intervention and Prevention Initiative (CVIPI) - FY 2022 Grant Award

Transmitted herewith for Mayor and City Council consideration is the Grant Acceptance Packet for the U.S. Department of Justice, Office of Justice Programs (OJP) 2022 Community-Based Violence Intervention and Prevention Initiative (CVIPI) Grant award in the amount of \$2,000,000, for the period of October 1, 2022 through September 30, 2025.

Through these grant funds, the Office of the Los Angeles City Attorney will enhance and expand existing community-led violence intervention partnerships with law enforcement, schools, community residents, victim service providers, community-based organizations, and researchers to prevent and reduce crime in the Southeast region of Los Angeles.

CVIPI will first administer a planning phase in which the convening of a CVIPI Working Group will conduct a community assessment on how best to stem the tide of violence. Upon completion of the planning phase, CVIPI will partner with Tessie Cleveland and other community-based organizations, to provide informed community driven direct services that will address trauma, provide opportunity, and improve the physical, social, and economic conditions that drive violence. Goals for the project will be the prevention or reduction of violent crime in the Southeast region of Los Angeles and to increase community participation in community-led violence intervention solutions.

The recipient (and any "subrecipient" at any tier) must have written procedures in place to respond in the event of an actual or imminent "breach" (OMB M-17-12) if it (or a subrecipient) -- (1) creates, collects, uses, processes, stores, maintains, disseminates, discloses, or disposes of "Personally Identifiable Information (PII)" (2 CFR 200.1) within the scope of an OJP grant-funded program or activity, or (2) uses or operates a "Federal information system" (OMB Circular A-130). By signing and accepting this award on behalf of the recipient, the authorized recipient official accepts all material requirements of the award, and specifically adopts, as if personally executed by the authorized recipient official, all assurances or certifications submitted by or on behalf of the recipient that relate to conduct during the period of performance.

Failure to comply with one or more award requirements -- whether a condition set out in full below, a condition incorporated by reference below, or an assurance or certification related to conduct during the award period -- may result in OJP taking appropriate action with respect to the recipient and the award. Among other things, the OJP may withhold award funds, disallow costs, or suspend or terminate the award. DOJ, including OJP, also may take other legal action as appropriate.

Any materially false, fictitious, or fraudulent statement to the federal government related to this award (or concealment or omission of a material fact) may be the subject of criminal prosecution (including under 18 U.S.C. 1001 and/or 1621, and/or 34 U.S.C. 10271-10273), and also may lead to imposition of civil penalties and administrative remedies for false claims or otherwise (including under 31 U.S.C. 3729-3730 and 3801-3812).

Should any provision of a requirement of this award be held to be invalid or unenforceable by its terms, that provision shall first be applied with a limited construction so as to give it the maximum effect permitted by law. Should it be held, instead, that the provision is utterly invalid or -unenforceable, such provision shall be deemed severable from this award.



Compliance with DOJ regulations pertaining to civil rights and nondiscrimination - 28 C.F.R. Part 38

B. Employment eligibility confirmation with E-Verify
