Subject: RESOLUTION NO. 22-10077 – PROPOSED APPROVAL OF FIRST AMENDMENT TO AGREEMENT NOS. 19-3678 ARCADIS U.S., INC., 19-3679 BERG & ASSOCIATES, INC., 19-3681 HARRIS & ASSOCIATES, INC., 19-3682 INTEGRATED ENGINEERING MANAGEMENT AND SECOND AMENDMENT TO AGREEMENT NO. 19-3680 ANSER ADVISORY MANAGEMENT, LLC, ON-CALL CONSTRUCTION MANAGEMENT SERVICES

Pursuant to Section 373 of the City Charter, enclosed for your approval is Resolution No. 22-10077 authorizing approval of First Amendment to Agreement Nos. 19-3678 Arcadis U.S., Inc., 19-3679 Berg & Associates, Inc., 19-3681 Harris & Associates, Inc., 19-3682 Integrated Engineering Management and Second Amendment to Agreement No. 19-3680 Anser Advisory Management, LLC, for on-call construction management services. The proposed Amendments would increase the term of each Agreement for an additional two years for a total duration of seven years, and an increase to the agreement amounts of \$2,000,000, resulting in a total agreement amount of \$4,000,000 for each agreement. In total, aggregate compensation under the five agreements would increase by \$10,000,000, from \$10,000,000 currently to \$20,000,000 as proposed. The Port is responsible for all compensation required by these agreements. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article II, Section 2(f) of the Los Angeles City CEQA Guidelines; and
2. APPROVE POLA Resolution No. 22-10077 authorizing proposed approval of the First Amendment to Agreement Nos. 22-3678-A, 22-3679-A, 22-3681-A, 22-3682-A, and the Second Amendment to Agreement No. 22-3680-B.
