WHEREAS, salaries are set by collective bargaining agreements approved by the Los Angeles City Council in accordance with the City of Los Angeles Charter, Section 219; and

WHEREAS, pursuant to negotiations with the International Brotherhood of Electrical Workers, Local 18, as part of the collective bargaining agreements reached for the term of October 1, 2022, to September 30, 2026, it was agreed to establish the new DDR for the classification of LMA, Class Code 3882, DDR No. 95-38820; and to modify the salary for the classification of LMA, Class Code 3882, and whereby, the City Council approved the salaries for LMA on October 28, 2022:

WHEREAS, the actions specified above shall be effective on the date the Board of Water and Power Commissioners adopts this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the DDRs identified by the DDR numbers listed above are hereby adopted to fix the duties and responsibilities of the positions created thereunder, and the number of positions authorized is hereby fixed as set forth above; and Schedule "B" of the Position Evaluation and Compensation Plan (Resolution No. 327, adopted October 9, 1947) as amended, the Departmental Personnel Resolution (Resolution No. 328, adopted October 9, 1947) as amended, and adopted

on October 28, 2022, by the City Council, is hereby further amended to reflect this action.

BE IT FURTHER RESOLVED that the Chief Accounting Employee of LADWP, upon proper certification, is authorized and directed to draw demands on the Water and Power Revenue Funds, in accordance with the terms of this Resolution.
