Erin Pak serves as the CEO of Kheir (pronounced 'care') Clinic, a non-profit Federally Qualified Health Center, which provides culturally and linguistically appropriate Medical, Dental, Optometry, and Adult Day Health care services to low income, underserved residents of Los Angeles. Under Erin's leadership, Kheir grew 678% in its annual revenue and over 3000% in total assets. In the recent years, Kheir was honored as the 2022 California Assembly (AD54) *Nonprofit of the Year*, 2020 *Los Angeles Business Journal Community Clinic of the Year*, and also recognized by the US Health & Human Services Department as a national leader in its innovative COVID vaccination response. Kheir Clinic remains the only nonprofit health clinic in the nation that delivers full suite of services in English, Bengali, Korean, Spanish and Thai.

Prior to joining Kheir Clinic, Erin held several marketing leadership positions with Fortune 500 companies and set revenue records in new markets. As an education consultant, Erin personally authored and secured \$125 million in federal grants for California public schools over a 45-month period. A dedicated community advocate, Erin has volunteered with various organizations to improve public school education and to raise community awareness and engagement levels in many areas, including voter registration, health and cancer screenings, and increased public library hours. For City of Los Angeles, Erin has served on the Ethics Commission, Commission on Community & Family Services, President's Joint Commission on LAUSD Governance, and the Getty House Board of Directors. In 2017, she was appointed to the First 5 California State Commission. Her current activities include Hollywood Presbyterian Medical Center Board of Directors, SoCalGas Community Advisory Board, and Clinic Mutual Insurance Company Purchasing Group Board of Directors, which provides professional liability insurance exclusively for nonprofit community clinics in the western states.

For her critical work on reducing health disparities in Los Angeles, Erin has been honored by the American Cancer Society, Turbo Air Foundation, the Korean American Health Coalition, and, by the California State Assembly, as part of Women's History Month 2010 and 2017. Erin holds a BA in Psychology and a Master of Science degree in Education with emphasis in Secondary & Adult Education, Training & Curriculum Design from the University of Southern California.

I am pleased to inform you that I hereby appoint you to the Board of Transportation Commissioners for the term ending June 30, 2026. In order to complete the process as quickly as possible, there are several steps that must be taken, many of which require visiting City Hall. To begin the appointment process, please review, sign, and return the enclosed Remuneration Form and Undated Separation Letters **within one week** of receiving this letter. These documents are necessary to ensuring the most efficient, open, and accountable City government possible. Further, Mayor's Office policy requires all potential commissioners to be fingerprinted as part of the background check. The Commissions Team will assist in connecting you with the Personnel Background Unit so that you may schedule an appointment to have this done. You must schedule the appointment **within one week** of receiving this letter.

Should this apply to your Commission, you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws, and a copy of the State Form 700/Statement of Economic Interests. You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission at 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012. Once you are confirmed, you will be required to take the oath of office in the City Clerk's Office in Room 395 of City Hall.

Commissioners must be residents of the City of Los Angeles. If you move at any point during your term, have any changes in your telephone numbers, or in the future plan to resign (resignation must be put in writing), please contact my office immediately.
