RENATA SIMRIL

President & CEO LA84 Foundation

Renata Simril is the President & CEO of the LA84 Foundation, the youth-serving organization committed to transforming the lives of young people across Southern California through ongoing investments in sports and play programs, infrastructure, research and education as the legacy of the 1984 Summer Olympic Games.

Since her appointment in 2016, Simril has strengthened and expanded the mission of the LA84 Foundation in vital ways by focusing its work on supporting childhood health, socio-emotional development and community well-being. She works collaboratively with corporate partners, sports organizations and philanthropies to bring new resources to communities and close the gaps in access to sports and play.

Simril has elevated the LA84 Foundation's profile as a national leader in the role that sports have in positive youth development. She has achieved this by growing the opportunities available for kids in Southern California, increasing awareness about how tangible issues today will significantly impact future generations, and by engaging new stakeholders to improve the social, academic and health outcomes for youth.

An enduring commitment to young people, organizational development and inclusive grantmaking strategies all inform Simril's relentless pursuit of seeking the greatest impact in this work. However, her aim to bring innovation and bold actions to alter the trajectory of generational challenges is also demonstrated by an ambitious collaborative agenda she launched to galvanize stakeholders. She conceptualized and founded the play equity movement to unite those in education, sports, health, philanthropy, and the public sector as partners to drive meaningful change, and to inspire kids from all backgrounds to play.

This gave rise to the Play Equity Fund, the only nonprofit worldwide dedicated to play equity as a social justice issue — and Simril serves as the growing organization's president. To advance creating conditions for kids to succeed through sport, Simril has forged partnerships with the 12 pro sports teams of Los Angeles and Orange County, as well as partnered with the Riviera Country Club to bring access to golf to underserved communities. She was instrumental in developing the Super Bowl LVI Legacy Program, "Champions Live Here" — with the NFL providing funding for a mobile play vehicle to bring healthy activities to communities without playgrounds — in addition to support for 56 nonprofits across the region.

The focus of the LA84 Foundation and the Play Equity Fund is to expand access to youth sports and play opportunities, with an emphasis on underserved communities. Under Simril's leadership, resources are also dedicated toward youth coaching education and training. The LA84 Foundation has reached nearly 4 million youth since its inception, trained nearly 200,000 coaches, and has supported the construction and/or renovation of over 100 sports facilities and fields of play in Southern California.

As well as serving as an advisor to national youth sports task forces, boards, and commissions, Simril's writing as an advocate for the important role sport, play and movement has on childhood health and wellness has appeared in *Authority Magazine*, EdSource.org, *Forbes*, the *Los Angeles Business Journal*, the *Los Angeles Daily News* and *The Sacramento Observer*. She has also been featured as a source in broadcast, print and digital media. Simril is honored to be invited to serve as a Regents' Lecturer in the UCLA Department of Sociology, a program where distinguished leaders from fields outside of traditional academics enrich instruction.

With more than 25 years of diverse experience – including a background in government, business, publishing, and pro sports – Simril has a longstanding commitment to leadership and service. Prior to joining the LA84 Foundation, she served as Senior Vice President & Chief of Staff of the *Los Angeles Times*, with duties that included staff operations and special projects. She served as Senior Vice President of External Affairs for the Los Angeles Dodgers previously, where she oversaw the brand's restoration and managed the Dodgers Foundation. For over a decade Simril was in real estate development with Jones Lang LaSalle, Forest City Development and LCOR, Inc.

She worked to expand rental and affordable housing in Los Angeles as Deputy Mayor for Economic Development and Housing in the Hahn Administration. As a Development Deputy to a Los Angeles City Councilman, Simril worked to help rebuild communities in South Los Angeles after the 1992 civil unrest.

She began her career in the U.S. Army as a Military Police Officer, serving in Germany and domestically.

A third generation Angeleno who grew up in Carson, Simril is actively engaged in civic and community service in a variety of roles, including serving on the boards the Los Angeles Chamber of Commerce Board of Governors, the Los Angeles Sports & Entertainment Commission and the Los Angeles Dodgers Foundation. She also serves on the ESPN Return to Play Advisory Council and the PLAYs Coalition, efforts focused on closing the play equity gap nationally.

She formerly served as a Governor's Appointee on the State of California Science Center Board, where she led negotiations of lease agreements for USC to manage and operate the Coliseum and Sports Arena. She also served on the LA 2028 Olympic Bid Committee, as Chair of the Board of Regents for LMU and was a board member of the Lusk Center for Real Estate at USC.

Simril earned a bachelor's degree in Urban Studies from Loyola Marymount University and a Master's in Real Estate Development from USC. She lives in Studio City with her husband and two sons.

Dear Ms. Simril:

I am pleased to inform you that I hereby appoint you to the Board of Recreation and Parks Commissioners for the term ending June 30, 2023, subject to confirmation by the City Council. In order to complete the process as quickly as possible, there are several steps that must be taken, many of which require visiting City Hall. To begin the appointment process, please review, sign, and return the enclosed Remuneration Form and Undated Separation Letters **within one week** of receiving this letter. These documents are necessary to ensuring the most efficient, open, and accountable City government possible. Further, Mayor's Office policy requires all potential commissioners to be fingerprinted as part of the background check. The Commissions Team will assist in connecting you with the Personnel Background Unit so that you may schedule an appointment to have this done. You must schedule the appointment **within one week** of receiving this letter.

Should this apply to your Commission, you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws, and a copy of the State Form 700/Statement of Economic Interests. You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission at 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012. Sometime thereafter, you will be notified by the committee clerk when your appointment will be presented to the full City Council for confirmation. Once you are confirmed, you will be required to take the oath of office in the City Clerk's Office in Room 395 of City Hall.

Per the Charter, Commissioners must be residents of the City of Los Angeles. If you move at any point during your term, have any changes in your telephone numbers, or in the future plan to resign (resignation must be put in writing), please contact my office immediately.
