DETAILS: (IF MORE SPACE IS NEEDED GO TO NEXT PAGE)

I have been assigned as Senior Lead Officer for the Leimert Park Community (Basic Car 3A73) for the past 4 years. My responsibilities include addressing ongoing quality of life and crime concerns for the area and being a liason to residents. I have received multiple complaints from the community regarding Rasta Smoke Shop at 4058 Crenshaw Blvd. The following points summarize the concerns all of which I have observed while providing enforcement and routine extra patrol:

- 1. Illegal parking in the north alley, causing traffic along Crenshaw Blvd to back up because vehicles are forced to enter/exit the alley facing opposing traffic.
- 2. Illegal parking in CBC Seafood/Kabachi (formerly Lousiana Chicken) disabled parking spot with no disabled placards. Note: There is only one disabled parking space so this is especially concerning.
- 3. Minors entering the Smoke Shop to purchase items, especially during the school year at Audubon Middle School dismissal.
- 4. Extensive litter alongside wall, including liquor bottles, no attempt by Rasta Smoke Shop to maintain
- 5. Extensive graffiti on building and has continously been in overall disrepair including need of painting
- 6. Business attracts loitering of customers and non-customers
- 7. Business owner at CBC Seafood Restaurant/Kabachi invested and beautified his building at 4050 Crenshaw, but have not seen any improvement at Rasta Smoke Shop, 4058 Crenshaw, immediately next door. Both the former business, Louisiana Chicken and CBC owners have expressed their concerns of Rasta Smoke Shop having a negative impact on their businesses.
- 8. In four years, I have never seen employees inspect or clean the exterior of the business, other than the one time that I asked them to observe the barricades I placed in the alley to prevent vehicles from parking alongside their building.
- 9. Landlord of 4058 Crenshaw is absentee and dismissive regarding above stated concerns. I have asked her to encourage Rasta Smoke Shop to make improvements but she refused.
- 10. On 7/23/21, I was informed by a community member that a former employee of Rasta Smoke Shop has been loitering in the area negatively affecting their quality of life. The community member also stated that the former employee is loitering in the rear alley of the smoke shop and causing a disturbance to adjacent businesses.

Sorry this is so late, but it's been extremely busy the past 5 days or so.....

some of the issues that have been shared with me. I also met with our Gang Unit this afternoon to discuss what they have observed For the past 3 1/2 years as Senior Lead Officer, I have received multiple complaints from the community regarding Rasta Smoke Shop at 4058 Crenshaw Blvd. The following points highlight

- Gang Unit arrested an individual adjacent to the building with a firearm.
- Gang Unit was called to the alley 2 nights ago for "man with a gun". Although the firearm was not located, the witness appeared to be credible
- Vice Officers have cited the store for selling "single cigarettes" to customers which is against the law
- Crenshaw Blvd due to customers parking in the alley. I have asked store management to address this ongoing issue and they have done little to improve it. I have received multiple calls/texts from community members regarding parking in the alley. I have personally observed numerous traffic jambs both in the alley and northbound
- I have observed and cited customers of the location for parking in the disabled parking spot located adjacent to the alley.
- I have observed graffiti on the front of the business, the building needs to be painted, and has an overall look of disrepair and neglect
- I have observed loitering in front of the business ongoing.
- I have never observed the staff on the exterior of the building checking on the status of the alley problem.
- The employees appear to only use the rear entrance which is not available to customers it is located off a private employee parking lot with guard dog
- According to neighbors, the alley is very active, experiencing loud excessive music from vehicles. Customers also loiter on foot at adjacent closed businesses, and park in front of single family homes along 41st St and McClung Dr. It also appears that there is excessive graffil in the area. Additionally, residents have observed vehicles speeding from the alley to McClung Dr, a residential street. The overall consensus is that the negative impact is due to Rasta Smoke Shop.

Hope this helps, and please let us know how we can assist. We have done our very best at enforcing this location, so any help from other city departments is appreciated



SUMMARY

Since March of 2019, the Los Angeles Police Department (LAPD) Gang and Narcotics Division, (formerly known as Detective Support and Vice Division), in conjunction with LAPD Southwest Area has conducted a comprehensive investigation into the nuisance complaints emanating from 4058 South Crenshaw Boulevard, "Rasta Smoke Shop."

This smoke shop is located on the southeast corner of Martin Luther King Boulevard and Crenshaw Boulevard, which is located in Los Angeles City Council District 8 (CD 8). This establishment is a part of the Leimert Park section of Los Angeles. This location has been problematic and has fast become a nuisance for the Southwest community since January of 2019.

"Rasta Smoke Shop," is registered as a market which does not have the provision of selling alcohol on premises. The store is relegated to selling water, soda, tobacco and sundries.

Nuisance activity at the location consists of inebriated persons loitering in and around the store. There is an ever-present nuisance at the location as it has become a "Rollin 40s" criminal street gang stronghold.

These gang members, who cavort in the surrounding parking lot and alley, terrorize customers of both the smoke shop and the Hair and Wig store, that is located east of the smoke shop on MLK Boulevard.

Community complaints have been addressed to both Los Angeles City Attorney's Office, and Los Angeles City Council District 8 (Harris-Dawson) and Neighborhood Council for the area (signed Declarations pending).

Not only are the nuisance related crimes associated with this establishment problematic, but more importantly there is an element of violence that has now taken hold of the market and created a public safety concern for the community.

The following crime stats for the location coves a two year period for 4058 S. Crenshaw

- 415 Group
- 415 Juvenile Group
- 415 Man
- Assault with a Deadly Weapon (firearm)
- 415 Group smoking marijuana adjacent to the location (in alley)
- Robbery of a Business
- Sales of Tobacco to a Minor
- A total of **20** Calls for Service over a one year period.

Most troubling of these incidents is an incident that occurred on the premises involving the Business Owner of the establishment which involved he as a suspect pointing a loaded firearm at a customer.

The Business Owner was taken into custody for Assault with a Deadly Weapon involving a firearm (Investigation Confidential)

Investigative efforts at this location have revealed that there are sensitive sites near the intersection of Martin Luther King and Crenshaw Boulevard. These locations are:

- Crenshaw Shopping Plaza
- Public Bus Bench directly outside of the market
- Crenshaw Movie Theaters
- Audubon Middle School

Investigations:

 On March 31, 2019, Los Angeles Police Officers entered the location with a Minor Decoy person, posing as a customer. The Minor is verified under the age of 21 years of age. The Minor entered Rasta Smoke Shop. The Minor purchased one Swisher Sweets tobacco product, in violation of 308 PC, RFC # H04211. The violation was obtained from Ibrahim.

Once inside the store, Investigators established that the establishment was not in possession of a STAKE Act sticker at the point of sale, which is in violation of 22950 B&P. Investigators also noted that there was no permit to sell tobacco at the establishment at all.

• On April 20, Investigators reviewed the administrative query for Calls for Service generated for the southwest corner of Crenshaw Boulevard and Martin Luther King Boulevard. This market as well as the bus bench directly outside, which functions as a seating area for customers is a problem for patrons requesting public transportation.

Management allows dogs inside the establishment, single sales cigarettes, complete disarray of the store and a host of less than savory characters inside. During UC

operation, the operation was halted due to problems surrounding the store both inside and outside by criminal activity, posing great danger to the Minor Decoy.

- On February 24, 2020, an undercover tobacco inspection, Southwest Area Investigators
 entered the store posing as a customer. The officer was able to purchase a single sale of a
 cigarette, in violation of 308.2 B&P. The arrest for the sale was store owner, Hamad
 Ibrahim.
- On May 15, 2020, Detective Harris was notified by Southwest Area investigators that Rasta Smoke Shop Business Owner, Ibrahim was taken into custody for Assault with a Deadly Weapon with a firearm.
 - Apparently, a female customer (confidential), entered the store. She and Ibrahim became engaged in a dispute. The dispute became heated. Ibrahim removed a pistol from his waistband and pointed it at the female customer. The female victim fled scene and notified police who took Ibrahim into custody without incident.
- On April 20, 2020, Southwest Area Vice Unit received information from citizens that the Rasta Smoke Shop was operating after being warned of being "not" an Essential Business during Covid crisis.

Ibrahim attempted to convince officers that he was an essential business because he was a grocer (which he had not been previous). Ibrahim had exactly one carton eggs and several expired cartons of milk in the store. Ibrahim cited 8.77 under Mayoral Directive. For verification, Southwest Area investigators verified with County Health Department that Rasta Smoke Shop not deemed a "market/grocer."

To date, the number of Calls for Service have totaled 20, with a number of arrests of the Business Owner for this location. Southwest Area Vice supervision, the Los Angeles City Attorney's Office as well as Detective Support and Vice Division supervisors have attempted to educate Mr. Ibrahim regarding his store best practices.

At each citation, Ibrahim has been educated regarding the Sales of Tobacco to Minor and the seriousness of the offense. Mr. Ibrahim has also been educated regarding the alley to the rear of his store and the need for security to patrol the alleyway directly behind his store and the sidewalk in front of his store.

Mr. Ibrahim has been told about the public safety issue that is his business for the community. Mr. Ibrahim has been either unwilling or unable to correct deficiencies at this smoke shop and change the dynamics of the business and property.

It is the position of the Los Angeles Police Department to see **Revocation of Use** imposed at this location to remedy the nuisance activity. Very little has been implemented.

It is the responsibility of the citizens and Business Owners in the City of Los Angeles to maintain public safety in which patrons and our residents may remain in an environment in which their safety are not placed in jeopardy.

SOURCE OF ACTIVITY:

On May 19, 2019, Detective Support and Vice Division (DSVD) was conducting a Minor Decoy Operation throughout Southwest Area. The purpose of the operation was to address the unlawful procurement of tobacco products at retail locations by underaged persons/minors.

Sergeant II Garcia, Serial No. 27687, Detective III Dana Harris, Serial No. 35888, Detective III Armstrong, Serial No. 33711, and Detective II Ishitani, Serial No. 34227, were assigned to DSVD. Detective I Magapagal, Serial No. 34230, was assigned to 77th Division. Officer Trujillo, Serial No. 40066, Officer Churnock, Serial No. 40802, and I, Sergeant II Ercolano, Serial No. 37574, were assigned to Southwest Area Vice. We were all in plain clothes and driving unmarked police vehicles. Sergeants Garcia and Ercolano, and Detectives Harris, Armstrong, Ishitani, and Magapagal were assigned as the takedown team and were wearing Department-approved tactical vests.

At approximately 1300 hours, we conducted an investigation at Rasta Smoke Shop, located at 4058 South Crenshaw Boulevard, Los Angeles, RD 393. Incident No. 190519-001973.

INVESTIGATION:

At approximately 1305 hours, Officer Trujillo entered the above location (smoke shop) posing as a customer prior to the entry of the minor decoy. The minor entered the location and was successful in purchasing Swisher Sweets from clerk Management (DOB. in violation of 308(a)(1) PC – Sales of Tobacco to a Minor. Sergeants Garcia and Ercolano, and Detectives Harris, Armstrong, Ishitani, and Magapagal entered the location. was cited on RFC No. E57349 for the violation.

We observed that the location did not have an LA City Tobacco Retailer's Permit. Suspect-1 was present at the location and stated that he and his brother, Suspect-2, are the owners of the location and are both responsible for the location. I asked Suspect-1 if he had a current City tobacco permit and he stated that he was not sure. He called his brother and I spoke with Suspect-2 is via telephone. It atted he and his brother own the location together and both are responsible for it. He also stated he had requested an LA City permit, but had not received it. Neither suspect was able to produce a current, valid LA City Tobacco Retailer's Permit as required by 46.91(a) LAMC. They were also unable to produce any evidence that anyone had attempted to aquire a permit.

Based on our observations, both suspects' statements, and the fact that neither was able to produce a

valid LA City Tobacco Retailer's Permit, we formed the opinion that the location was in violation of 46.91(a) LAMC. Suspect-1 was as present at the location and claimed responsibility for the location. Suspect-2 was not present at the location, but also claimed ownership of the location and responsibility for it. Further, and name is on the City of LA Alarm Permit for the location. We request that a complaint for 46.91(a) LAMC be filed on both suspects.





We were working in full patrol uniform driving a black and white hybrid police vehicle when we responded a radio call of a "211 Silent at 4058 Crenshaw Blvd, Inc. # 1710030004649"

Investigation:

Upon our arrival, my partner briefly met with Witness 1 and Witness 2 who were standing inside the Rasta Smoke shop / Mini Mart and stated: "it was the guy with no shirt and pointed northbound Crenshaw". While en route to 4058 Crenshaw Blvd. My partner and I observed an irate male black yelling and aggressively walking between the number one lane and number three lane of Crenshaw Blvd on the east side of street. As my partner and I attempted to clear the intersection of Crenshaw Blvd and Martin Luther King Blvd the irate male black walked up to the rear driver quarter panel and began to aggressively hit our patrol vehicle with his hands. My partner and I proceeded to clear and cross the intersection of Crenshaw Blvd and Martin Luther King Blvd at which time the irate male black continued to yell and stand in the road.

After Witness 1 and 2 gave my partner and I the description of the suspect we immediately knew the suspect was the same irate individual whom we encountered on the northeast corner of Crenshaw Blvd and Martin Luther King Jr. Blvd while we were en route to 211 silent radio call.

3G23-W6 Officer Black and Officer Percy responded to 4058 Crenshaw and I advised them of the suspect location.

Prior to making contact with the suspect (later identified as my partner and I got back into our patrol vehicle and began to drive in the direction we last saw Officer Garcia #40475 requested a supervisor to respond to our location. Before exiting our patrol vehicle and making contact with we discussed tactics. I, Officer Thompson agreed to be the contact and my partner Officer Garcia agreed to be less lethal (TASER).

My partner and I, immediately recognized the suspect (later identified as sitting down on a green bus bench located on the northeast corner of Crenshaw Blvd and Martin Luther King Blvd just west of the Krispy Cream Donuts. immediately got up off the bench as we arrived in our patrol vehicle. My partner and I exited our patrol vehicle and began to give him verbal commands to turn around as he continued to approach the front of our patrol vehicle.

I then began to give verbal commands to turn around. Failed to comply with my verbal commands and quickly took a fighting stance and closed the distance between him and I. I then pushed away with my right hand to create distance and verbal warned him that he was going to get tased if he did not comply.

Use of Force:

Due to be taking a fighting stance and it being unsafe for us to approach him and his aggressive demeanor.

Officer Garcia #40475 deployed the TASER in attempt to control actions. The darts struck on his left side of the upper torso. Stiffened in reaction to the TASER but remained standing and continued to step away. Believing that TASER appeared to be ineffective and was going to continue to walk away and rip the darts of his person, Officer Garcia reactivated the TASER a second time in an attempt to gain second complement of the ground and stiffened in reaction to the TASER. While was being tased my partner and I continued to give him verbal commands to comply.

3G23-W6 Officer Black Serial No. 40620 and his partner Officer Percy Serial No. 39777 responded to our location and assisted taking into custody. Officer Black arrived and placed his left hand on support back and used his right hand to attempt gain control of some solutions is left arm to bring behind his back. It is refused to comply and then placed his arm under his torso. My partner and I continued to verbalize with I comply with officers. It is a continued to keep his arm under his upper torso.

Officer Black attempted to subdue substantial selft arm and was unsuccessful. Officer Garcia then applied a drive-stun away from the impact site of the probes (right side of his torso) to regain compliance. Officer Black was then able to regain control of selft arm by using his left and right hand and placing a firm grip on selft arm. At which time Officer Black applied his body weight on supper and mid-back (left side) using his right and left knee to keep on the ground and from turning on officers while we attempted to take into custody. Simultaneously Officer Percy #39777 placed his right knee on supper back and used body weight to keep from getting up until he was taken into custody.

I placed firm grip with my left and right hand on stiffened his arm, I then placed my left knee on solver solver back and applied my body weight in order to bring right arm behind his back maintained the firm grip with my two hands on his right arm. Officers Tobias# 39622 and Moreno #41217 working 3G52-W6 met with the other store employee during the crime, Wit-2 was admonished of the field show-up and transported to the area of the suspect being detained. Wit-2 had a clear unobstructed view of the Suspect He positively identified the Suspect detained as the one who went inside the store and began throwing and breaking the items in the store and taking items without permission.

My partner Officer Garcia #40475 and I Officer Thompson spoke with the wits who said that they were working at the store when the Suspects entered and just began yelling at everyone. He approached the glass barrier and began banging on it demanding items. In fear and an attempt to calm the suspect down, they handed him a single cigarette. Prior to the use of force, officers observed a cigarette in the suspect's hand that he placed in his mouth right before the use of force. Wits then said the Suspect began tipping over all the food racks one by one and throwing the food outside or kicking it around. He then went to the soda coolers and began throwing soda cans around. In fear, the witness then barricaded themselves behind the protective plexiglass wall in the store and hit the silent alarm button. The witness said he threw many items outside the store and appeared to take many items with him when he left.

My partner and I also watched the surveillance video of the incident and observed Suspect tipping over food racks and throwing items outside and around in the store, the video also shows Suspect leaving the store with an unknown amount of items in his hand at different points and then returning inside the store to grab more items.

At approximately 1700 hours, Sgt II Ercolano (OIC), my partners Officer Trujillo, Officer Martinez, and I, responded to "Rasta Smoke Shop." We met the clerk behind the counter. We asked for the owner and he called him via cellular phone. Sgt II Ercolano spoke with the over the phone and advised and warned that they are ordered to shut down operations.

On 04/19/2020 at approximately 1615 hours, Southwest Footbeat Unit observed "Rasta Some Shop" to be open and operational. Southwest Footbeat Unit advised via a phone call to shut down and not to operate.

On 04/20/2020 at approximately 1630 hours Sgt II Ercolano (OIC) along with my partners, Officer Trujillo, Officer Martinez and I, responded to "Rasta Smoke Shop." Immediately upon pulling into the parking lot we observed the business to be open and operational with customers inside.

While I was interviewing the victim, she identified the suspect by pointing him out. Victim had a clear and un-obstructed view of the suspect.



On 04/20/2020, my partners, Officer Trujillo #40066, Officer Martinez #42076, and I, Officer Moreno #39512, were assigned to the Southwest Area Vice Unit. We were driving a plain vehicle, and dressed in full Police uniform, along with Sgt. II Ercolano #37574, who was assigned as OIC. We were directed to enforce the LA City Safer at Home Emergency Order per the Neighborhood Prosecutor.

Investigation:

On 04/14/2020 at approximately 1700 hours my partners Officer Trujillo, Officer Martinez, and I, drove by "Rasta Smoke Shop" located at 4058 South Crenshaw Blvd. We observed approximately 10 patrons inside the business. We are very familiar with the interior of the location (lobby area), to be approximately 15 feet in length and approximately 6 feet in width. Based on being familiar with the lobby space and the number of patrons inside the business, it was clear, that the business was not practicing social distancing as directed per the Emergency Order.

On 04/17/2020 we were notified by the City Attorney's Office that "Rasta Smoke Shop" was deemed a non-essential business. At approximately 1700 hours, Sgt II Ercolano (OIC), my partners Officer Trujillo, Officer Martinez, and I, responded to "Rasta Smoke Shop." We met the clerk behind the counter. We asked for the owner and he called him via cellular phone. Sgt II Ercolano spoke with the counter was acknowledged and instructed the clerk to lock and secure the business.

On 04/19/2020 at approximately 1615 hours, Southwest Footbeat Unit observed "Rasta Some Shop" to be open and operational. Southwest Footbeat Unit advised via a phone call to shut down and not to operate.

On 04/20/2020 at approximately 1630 hours Sgt II Ercolano (OIC) along with my partners, Officer Trujillo, Officer Martinez and I, responded to "Rasta Smoke Shop." Immediately upon pulling into the parking lot we observed the business to be open and operational with customers inside.

We met with and advised him that he would be receiving a citation due to it being the third time he was being ordered to shut down operations, per the LA City Attorney's Office guidance. During our visit, customers, unawarc of our presence, were heard ordering single cigarettes through the service window. Ibrahim and clerks at the location have been previously cited for the sales of single cigarettes in violation 308.2(a) PC and sales of tobacco to a minor in violation 308(a)(1) PC.
