3. Authorize the City Clerk to submit the petition to the Los Angeles County Registrar-Recorder/ County Clerk.


FISCAL IMPACT STATEMENT

RESOLUTION

Resolution requesting the Los Angeles County Registrar-Recorder/County Clerk provide election related services to examine the signatures on an initiative petition submitted to the City of Los Angeles regarding the following subject: Limits on Healthcare Executive Compensation.

WHEREAS, the Proponents of the initiative described above filed their petition with the City Clerk of the City of Los Angeles, on February 14, 2023; and

WHEREAS, the City Clerk has completed the random sampling signature review process of the initiative petition and has concluded that the valid number of randomly sampled signatures falls within the range that requires all petition signatures submitted to be examined pursuant to the City of Los Angeles Election Code Section 711(b) and

WHEREAS, considering the large number of signatures submitted on this initiative petition, the City Clerk does not have the capacity to conduct a full examination of all of the submitted petition signatures in a timely manner; and

WHEREAS, City Election Code Section 105(e) authorizes the City to request the County to render specified election services to the City Clerk.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The City Council respectfully requests the Board of Supervisors of the County of Los Angeles to direct the Los Angeles County Registrar-Recorder/County Clerk to render specified services to examine the signatures on the initiative petition submitted to the City of Los Angeles regarding Limits on Healthcare Executive Compensation and certify the results of that examination.

Sec. 2. The City Council requests the Board of Supervisors to fix the costs to be paid by the City of Los Angeles for the County’s examination of the initiative petition. The City of Los Angeles will reimburse the County of Los Angeles for the costs incurred in the examination of the initiative petition and any related costs arising out of or incurred in connection with review or challenge of that examination, consistent with the cost estimate provided by the Registrar-Recorder/County Clerk and agreed to between the County and the City.
