Subject: FIRST AMENDMENT TO AGREEMENTS BETWEEN THE CITY OF LOS ANGELES

DEPARTMENT OF TRANSPORTATION AND 97 FIRMS ON THE DEPARTMENT'S LIST OF

ON-CALL PROFESSIONAL CONSULTANTS SERVICES

SUMMARY

The attached report was transmitted by the Mayor to the Department of Transportation (LADOT). This report is now referred to the Council for review and approval of the 97 On Call Professional Bench Agreements extension.

RECOMMENDATION

That the Council:

- Authorize the General Manager of the Department of Transportation, or designee, to execute an 18-month extension, expiring on August 31, 2024, with each of the 97 firms of the Department's on-call professional consultant services list attached to this report (Attachment A), contingent on each firm submitting all required contractor compliance documents prior to execution of initial contract and subsequent Task Order Agreements and forward these contract extensions to the Council for consideration; and
- 2. Instruct the Department of Transportation to report annually to the Mayor and the City Administrative Officer regarding all executed Task Orders using this on-call list in order to promote transparency.

BACKGROUND

In February 2020, the Office of the Mayor authorized LADOT to execute 119 contracts with various consultants and firms to establish a pre-qualified list to provide On-Call Professional Consultant Services with varying and temporary work assignments in several service categories: Information Technology Services, Marketing and Public/Media Relations Services, Public Engagement Services, Parking Consulting Services, Transit Consulting Services, Engineering and Design Consulting Services, Transportation Planning Services, Urban Design and Planning Services, RFP and Grant Writing Services, Training and Professional Development Services, Audit Services, Management Consulting Services, and Construction Management Services. These contracts had three-year terms, which expired in February, March, and April 2023.

As funding for a project becomes available, LADOT is required to issue Task Order Solicitations, with the scope of work, tasks, and deliverables, to a specific service category seeking proposals from the pre-qualified on-call professional service consultants with matching service requirements. When LADOT selects a consultant/firm, a separate contract (Task Order Agreement) is executed, and a Notice to Proceed letter to begin work is sent to the contractor.

In 2020, prior to the COVID-19 pandemic, LADOT executed the On-Call Professional Consultant Services Contracts. The COVID-19 pandemic hindered LADOT's ability to issue Task Order Solicitations and fully utilize the bench of contractors for the first 12-18 months of the contract term due to the City's Cost Containment policy. LADOT seeks, in these 97 amendments, additional time to utilize the pre-qualified consultants for Task Order Solicitations. The extension also allows for completion of 11 open task order projects.

DISCUSSION

LADOT recommends the execution of the 97 contract amendments to provide the Department time to release a new Request for Qualifications (RFQ) and establish a new On Call Professional bench. Extending the contract term will also provide project managers and key Department initiatives sufficient time to complete the current work and allow the additional work to be completed through a task order solicitation.

LADOT intends to release the RFQ in the third quarter of 2023. These Amendments serve as a stop-gap measure to ensure LADOT's uninterrupted ability to release Task Order Solicitations while a new pre-qualified consultant list is established.

FINANCIAL IMPACT

There is no impact on the General Fund. The Department's use of the proposed on-call professional consultant services list depends on securing funds through the department's budget, project budget, special purpose fund appropriations, grants, or other budget actions for the requested consultant services.

SUMMARY

The Department of Transportation (LADOT) has ongoing needs for on-call professional consultant services to assist with the delivery of projects and services related to the Department's Strategic Plan, the City's Mobility Plan, the Sustainable City pLAn, the Great Streets initiative, the Vision Zero initiative, transportation grant programs, and various programs as directed by the Mayor and City Council. These needs are highly specialized and intermittent in nature. While LADOT uses in-house, existing staff as much as possible, the on-call professional consultant services bench allows the Department to enhance and expand its capacity to deliver projects on schedule and to supplement staff knowledge with specialized expertise.

The Department is requesting to extend the on-call consultant bench contracts. The Department reached out to all 122 consultants on the bench to determine interest in extending their bench contracts. 26 firms were non-responsive and as a result the Department submitted a memo requesting to continue contracts for 96 consultants. Subsequent to the Department of Transportation memo requesting the extension of 96 consultants, Estolano Advisors, the consultants responsible for work order AA-002 Traffic Enforcement Study and Outreach, communicated their interest in extending their contract bringing the total to 97 contracts for extension.

The current on-call consultant bench contracts have been active since February 2020. Over the past three years 17 task orders have been issued with two of the task orders completed as detailed in Attachment A. The task orders issued to date approximate a total value of \$5.5 million.

The Department has indicated that there are 12 open Task Orders assigned to firms on the list. A summary of these Task Orders is as follows:

Council approval of the proposed agreements are required as the term of each proposed agreement will exceed three years. Some of the agreements will be expired by the time the Council considers them. Therefore, the City Attorney and the Department have inserted ratification language into the extensions to allow those contractors with existing Task Orders to receive payment for work completed prior to execution of the extensions.

The Department has stated that they will issue a new Request for Qualifications (RFQ) to establish a new list in 2024. As of February 14, 2023, the Department has yet to draft the RFQ. It is recommended that the extended contracts expire on August 31, 2024 to allow sufficient time to complete the RFQ process, provide project management flexibility, support grant funding, and address workload issues within this Office.

BACKGROUND

The on-call consultant bench provides expertise across 13 service categories as follows:

Continuing On-Call Consultant Services Categories

- Information Technology Services
- Marketing & Public/Media Relations Services
- Public Engagement Services
- Parking Consulting Services
- Transit Consulting Services
- Engineering & Design Consulting Services
- Transportation Planning Services

- Urban Design & Planning Services
- RFP & Grant Writing
- Training and Professional Development
- Audit Services
- Management Consulting
- Construction Management

A brief description of each of the 13 on-call professional consultant services categories is provided below.

Information Technology Services - systems development and implementation; database management and organization; systems analysis and integration; data/document capture, conversion, and loading; programming services; and general information technology consulting services.

Marketing and Public/Media Relations Services - marketing services, strategies, and campaigns; government public relations services; opinion polling and surveys; media relations and media inquiries; and develop and manage social media content.

Public Engagement Services - community and/or civic outreach and engagement; coordination with elected officials, neighborhood councils, and other City and local agencies regarding public meetings for various projects; and safety education program development and implementation.

Parking Consulting Services - parking demand, supply, and/or occupancy studies for use in determining parking needs; parking rate comparisons and studies; analysis, design, and delivery of parking equipment and technology; and evaluation and management of existing and new parking facilities.

Transit Consulting Services - studies to determine and forecast model transit ridership demand; transit safety and security; analysis of new transit-related technology; vehicle inspections and maintenance quality assurance review; assessment of transit bus routes; and assistance with Transit's Bus Yard Electrification program.

Engineering and Design Consulting Services - traffic engineering; civil engineering; electrical engineering/communications systems engineering; computer-aided drafting services; preparation of area-wide Neighborhood Traffic Management plans; prepare traffic simulation studies, conceptual plans, and estimates for traffic calming measures; prepare before and after comparison analyses; and prepare speed zone surveys.

Transportation Planning Services - project management expertise in transportation planning and engineering, including review of mitigation measures proposed by developers, Transportation Demand Management strategies and plans, and mobility improvement studies; preparation of traffic demand forecast models; preparation of transportation planning studies and analyses; and develop pedestrian, bicycle, safe routes to school, and first/last mile connectivity and mobility plans, infrastructure assessments, and recommendations for funding, phasing, and implementation.

Urban Design and Planning Services - design of public realm, public open space, road configurations, and streetscape design; assessment and inventory of physical, social, and environmental elements and site conditions; assessment of active transportation-related programs; planning and project feasibility studies for urban design strategies; and analysis and evaluation of existing mobility, traffic studies and planning, and pedestrian and community enhancements.

Request for Proposals (RFP) and Grant Writing - development, writing, and management of grant applications and solicitations for service for the City and/or LADOT; assistance with grant preparation and administration for local, regional, state, and federal funding; and preparation of Requests for Proposals and/or Qualifications, including development of scope of work and evaluation criteria.

Training and Professional Development - design, administration, and delivery of professional development services for staff at all levels and classifications; and specialized training specific to Department needs and the professional development and job performance of LADOT staff.

Audit Services - provide financial and performance audits in accordance with generally accepted auditing standards; conduct operational reviews and contract compliance audits; provide quality control for relevant data and findings; produce reports; provide data analysis and data visualization services.

Management Consulting Services - strategic management services including development of longrange strategic plans and providing recommendations relating to current and future policies; operations management services including needs assessments, asset inventory, customer service studies, and development of benchmark goals and performance indicators; project management service; and risk and compliance management, including risk and security assessments.

Construction Management Services - experience as a Construction Manager with construction oversight to business models of Design-Bid-Build and Design-Build deliveries; determination of construction feasibility and/or shovel-readiness; and provision of value-engineering and construction risk assessments.

The use of the on-call professional consultant services list is contingent upon securing funding on a project-by-project basis through the Department budget, a capital project budget, a special purpose fund appropriation, a grant or other budgetary actions prior to engaging any consultant for service. LADOT does not guarantee any minimum amount of business or compensation for firms recommended on this on-call professional consulting services bench.

Subject: TERM EXTENSIONS FOR LADOT ON-CALL PROFESSIONAL SERVICES AGREEMENTS

SUMMARY

The Los Angeles Department of Transportation (LADOT) requests authorization to amend 96 On-Call Professional Consultant Services contracts that expire in February, March, and April of 2023. The contract amendments extend the term of the Agreements for 12 months. The term extension allows LADOT to continue utilizing the bench to issue bid letters (Task Order Solicitations) while LADOT prepares and releases a Request for Qualification (RFQ) to establish a new On-Call Professional Consultant Services bench.

RECOMMENDATION

That the Council, subject to concurrence by the Mayor,

AUTHORIZE the General Manager of LADOT, or designee, to execute contract amendments for the On-Call Professional Consultant Services contracts identified in the chart below to extend the term of the contracts which will allow LADOT to continue the use of the current consultants to release Task Order Solicitations for competitive bids with the same terms and conditions as the original contract.

BACKGROUND

In February 2020, the Office of the Mayor authorized LADOT to execute 119 contracts with various consultants and firms to establish a pre-qualified list to provide On-Call Professional Consultant Services with varying and temporary work assignments in several service categories. These contracts had three-year terms which will start to expire in February 2023.

As funding for a project becomes available, LADOT is required to issue Task Order Solicitations, with scope of work, tasks, and deliverables, to a specific service category seeking proposals from the pre-qualified on-call professional service consultants with matching service requirements. When LADOT selects a consultant/firm, a separate contract (Task Order Agreement) is executed and a Notice to Proceed letter to begin work is sent to the contractor.

In 2020, prior to the COVID-19 pandemic, LADOT executed the On-Call Professional Consultant Services Contracts. The COVID-19 pandemic hindered LADOT's ability to issue Task Order Solicitations and fully utilize the bench of contractors for the first 12 to 18 months of the contract term due to the City's Cost Containment. LADOT seeks, in these 96 amendments, additional time to utilize the pre-qualified consultants for Task Order Solicitations. The extension also allows for the completion of 10 open task order projects.

The recommended contract extensions also allow sufficient time for LADOT to issue a new request for qualifications (RFQ) to solicit consultants to establish a new pre-qualified list for On-Call Professional Consultant Services to replace the current list. LADOT intends to release the RFQ in the first quarter of 2023. These Amendments serve as a stop-gap measure to ensure LADOT's uninterrupted ability to release Task Order Solicitations while a new pre-qualified consultant list is established.

FISCAL IMPACT

There is no impact to the General Fund. The Department's use of the On-Call Professional Consultant Services list is dependent on securing funds through the Department's budget, project budget, or other budget actions for the requested consultant services.

Formal notices, demands, and communications to be given by either Party must be made in writing (hardcopy or e-mail) and may be effected by personal delivery or by registered or certified mail, postage prepaid, return receipt requested and will be deemed communicated as of the date of mailing.

4. **Section 3.1 Term,** is hereby amended in its entirety and replaced by the following:

This Agreement shall be in effect beginning 2/14/2020 ("Effective Date") and shall terminate on 2/13/2024, unless otherwise terminated in accordance with the termination provisions herein.

5. **Section 3.4 Ratification**, is hereby added immediately following **Section 3.3 Contract Modifications** to read as follow:

The Consultant may have provided prior services to the City of Los Angeles under the terms of an executed Agreement which included a requirement to adhere to the City's Standard Provisions for City Contracts. To the extent that the Consultant provided services to the CITY prior to the execution of this extension, and the Consultant's services were performed in accordance with the terms and conditions of this extension and the original Agreement, including the City's Standard Provisions for City Contracts, those services are hereby ratified.

- 6. Attachment A Standard Provisions for City Contracts is hereby replaced in its entirety by Attachment A Standard Provisions for City Contracts (Rev. 9/22) [v.1] attached hereto and incorporated herein.
- 7. Effective the date of attestation by the City Clerk of this First Amendment, all references to Standard Provisions for City Contracts throughout the Agreement are hereby deleted and replaced with the

8. **Section 12. STANDARD PROVISIONS FOR CITY CONTRACTS**, is hereby amended in its entirety to read as follows:

By entering into this Agreement with the CITY, the CONTRACTOR agrees to abide by the provisions set forth in Attachment A - Standard Provisions for City Contracts (Rev. 9/22) [v.1] attached hereto and incorporated herein.

9. Effective the date of attestation by the City Clerk of this First Amendment, the Agreement is hereby amended by renaming Section 13. ENTIRE AGREEMENT to Section 13. ADDITIONAL REQUIREMENTS, with Subsections 13.1 Municipal Lobbying Ordinance, 13.2 Fair Chance Initiative for Hiring Ordinance, 13.3 Consultant Evaluation Ordinance, and 13.4 COVID-19 Vaccination Ordinance to read as follows:

13. ADDITIONAL REQUIREMENTS

13.1 Municipal Lobbying Ordinance

The Consultant is required to comply with the disclosure requirements and prohibitions established in the Los Angeles Municipal Lobbying Ordinance if Consultant qualifies as a lobbying entity under Los Angeles Municipal Code §48.02. Agreements submitted without a completed CEC Form 50 by consultants that qualify as a lobbying entity under Los Angeles Municipal Code §48.02 may be subject to penalties, termination of contract, and debarment.

13.2 Fair Chance Initiative for Hiring Ordinance

The Consultant shall be subject to the Fair Chance Initiative for Hiring Ordinance (Consultant's Fair Chance Initiative for Hiring Ordinance Use of Criminal History for Consideration of Employment Applications Ordinance). The Ordinance provides, among other things, that consultants and/or subconsultants with at least 10 employees are: prohibited from seeking a job applicant's criminal history information until after a job offer is made; must post Fair Chance Initiative for Hiring Ordinance information in conspicuous places at worksites; and cannot withdraw a job offer based on an applicant's criminal history unless a link has effectively been made between the applicant's criminal history and the duties of the job position.

The Consultant seeking additional information regarding the requirements of the Fair Chance Initiative for Hiring Ordinance may visit the Bureau of Contract Administration's website at http://bca.lacity.org.

13.3 Consultant Evaluation Ordinance

At the end of this Agreement, the City will conduct an evaluation of the Consultant's performance. The City may also conduct evaluations of the Consultant's performance during the term of the Agreement. As required by Section 10.39.2 of the Los Angeles Administrative Code, evaluations will be based on a number of criteria, including the quality of the work product or service performed, the timeliness of performance, financial issues, and the expertise of personnel that the Consultant assigns to the contract. A Consultant who receives a "Marginal" or "Unsatisfactory" rating will be provided with a copy of the final City evaluation and allowed 14 calendar days to respond. The City will use the final City evaluation, and any response from the Consultant, to evaluate proposals and to conduct reference checks when awarding other personal services contracts.

13.4 COVID-19 Vaccination Ordinance

Employees of Consultant and/or persons working on its behalf, including, but not limited to, subconsultants (collectively, "Consultant Personnel"), while performing services under this Agreement and prior to interacting in person with City employees, Consultants, volunteers, or members of the public (collectively, "In-Person Services") must be fully vaccinated against the novel Coronavirus 2019 ("COVID-19"). "Fully vaccinated" means that 14 or more days have passed since Consultant Personnel have received the final dose of a two-dose COVID-19 vaccine series (Moderna or Pfizer-BioNTech) or a single dose of a one-dose COVID-19 vaccine (Johnson & Johnson/Janssen) and all booster doses recommended by the Centers for Disease Control and Prevention.

Prior to assigning Consultant Personnel to perform In-Person Services, Consultant shall obtain proof that such Consultant Personnel have been fully vaccinated. Consultant shall retain such proof for the document retention period set forth in this Agreement.

Consultant shall grant medical or religious exemptions ("Exemptions") to Consultant Personnel as required by law. If Consultant wishes to assign Consultant Personnel with Exemptions to perform In-Person Services, Consultant shall require such Consultant Personnel to undergo weekly COVID-19 testing, with the full cost of testing to be borne by consultant. If Consultant Personnel test positive, they shall not be assigned to perform In-Person Services or, to the extent they have already been performing In-Person Services, shall be immediately removed from those assignments.

Furthermore, Consultant shall immediately notify City if Consultant Personnel performing In-Person Services (1) have tested positive for or have been diagnosed with COVID-19, (2) have been informed by a medical professional that they are likely to have COVID-19, or (3) meet the criteria for isolation under applicable government orders.

- 10. The existing **Section 13. ENTIRE AGREEMENT** and its **Subsections 13.1** through **13.3** are hereby renumbered to **Section 14. ENTIRE AGREEMENT** immediately followed by **Subsections 14.1** through **14.3**.
- 11. Section 14.3 Order of Precedence is hereby amended to read as follows:

14.3 Order of Precedence

This Agreement, and any exhibits, attachments, or documents incorporated herein by inclusion or by reference, constitutes the complete and entire Agreement between the City and the Consultant. In the event of any inconsistencies between the bodies of this Agreement and attachments, the order of precedence will be as follows:

- 1. This Agreement between the City of Los Angeles and AECOM Technical Services, Inc. and its Amendments
- 2. Attachment A Standard Provision for City Contracts (Rev. 9/22) [v.1]
- 3. RFQ for On-Call Professional Consultant Services
- 4. Consultant Proposal
- 12. Except as herein amended, all other terms and conditions of this Agreement shall remain unchanged and in full force and effect.

Formal notices, demands, and communications to be given by either Party must be made in writing (hardcopy or e-mail) and may be effected by personal delivery or by registered or certified mail, postage prepaid, return receipt requested and will be deemed communicated as of the date of mailing.

4. **Section 3.1 Term,** is hereby amended in its entirety and replaced by the following:

This Agreement shall be in effect beginning 2/14/2020 ("Effective Date") and shall terminate on 2/13/2024, unless otherwise terminated in accordance with the termination provisions herein.

5. **Section 3.4 Ratification**, is hereby added immediately following **Section 3.3 Contract Modifications** to read as follow:

The Consultant may have provided prior services to the City of Los Angeles under the terms of an executed Agreement which included a requirement to adhere to the City's Standard Provisions for City Contracts. To the extent that the Consultant provided services to the CITY prior to the execution of this extension, and the Consultant's services were performed in accordance with the terms and conditions of this extension and the original Agreement, including the City's Standard Provisions for City Contracts, those services are hereby ratified.

- 6. Attachment A Standard Provisions for City Contracts is hereby replaced in its entirety by Attachment A Standard Provisions for City Contracts (Rev. 9/22) [v.1] attached hereto and incorporated herein.
- 7. Effective the date of attestation by the City Clerk of this First Amendment, all references to Standard Provisions for City Contracts throughout the Agreement are hereby deleted and replaced with the following: Standard Provisions for City Contracts (Rev. 9/22) [v.1].
- 8. **Section 12. STANDARD PROVISIONS FOR CITY CONTRACTS**, is hereby amended in its entirety to read as follows:

By entering into this Agreement with the CITY, the CONTRACTOR agrees to abide by the provisions set forth in Attachment A - Standard Provisions for City Contracts (Rev. 9/22) [v.1] attached hereto and incorporated

herein.

 Effective the date of attestation by the City Clerk of this First Amendment, the Agreement is hereby amended by renaming Section 13. ENTIRE AGREEMENT to Section 13. ADDITIONAL REQUIREMENTS, with Subsections 13.1 Municipal Lobbying Ordinance, 13.2 Fair Chance Initiative for Hiring Ordinance, 13.3 Consultant Evaluation Ordinance, and 13.4 COVID-19 Vaccination Ordinance to read as follows:

13. ADDITIONAL REQUIREMENTS

13.1 Municipal Lobbying Ordinance

The Consultant is required to comply with the disclosure requirements and prohibitions established in the Los Angeles Municipal Lobbying Ordinance if Consultant qualifies as a lobbying entity under Los Angeles Municipal Code §48.02. Agreements submitted without a completed CEC Form 50 by consultants that qualify as a lobbying entity under Los Angeles Municipal Code §48.02 may be subject to penalties, termination of contract, and debarment.

13.2 Fair Chance Initiative for Hiring Ordinance

The Consultant shall be subject to the Fair Chance Initiative for Hiring Ordinance (Consultant's Fair Chance Initiative for Hiring Ordinance Use of Criminal History for Consideration of Employment Applications Ordinance). The Ordinance provides, among other things, that consultants and/or subconsultants with at least 10 employees are: prohibited from seeking a job applicant's criminal history information until after a job offer is made; must post Fair Chance Initiative for Hiring Ordinance information in conspicuous places at worksites; and cannot withdraw a job offer based on an applicant's criminal history unless a link has effectively been made between the applicant's criminal history and the duties of the job position.

The Consultant seeking additional information regarding the requirements of the Fair Chance Initiative for Hiring Ordinance may visit the Bureau of Contract Administration's website at http://bca.lacity.org.

13.3 Consultant Evaluation Ordinance

At the end of this Agreement, the City will conduct an evaluation of the Consultant's performance. The City may also conduct evaluations of the Consultant's performance during the term of the Agreement. As required by Section 10.39.2 of the Los Angeles Administrative Code, evaluations will be based on a number of criteria, including the quality of the work product or service performed, the timeliness of performance, financial issues, and the expertise of personnel that the Consultant assigns to the contract. A Consultant who receives a "Marginal" or "Unsatisfactory" rating will be provided with a copy of the final City evaluation and allowed 14 calendar days to respond. The City will use the final City evaluation, and any response from the Consultant, to evaluate proposals and to conduct reference checks when awarding other personal services contracts.

13.4 COVID-19 Vaccination Ordinance

Employees of Consultant and/or persons working on its behalf, including, but not limited to, subconsultants (collectively, "Consultant Personnel"), while performing services under this Agreement and prior to interacting in person with City employees, Consultants, volunteers, or members of the public (collectively, "In-Person Services") must be fully vaccinated against the novel Coronavirus 2019 ("COVID-

19"). "Fully vaccinated" means that 14 or more days have passed since Consultant Personnel have received the final dose of a two-dose COVID-19 vaccine series (Moderna or Pfizer-BioNTech) or a single dose of a one-dose COVID-19 vaccine (Johnson & Johnson/Janssen) and all booster doses recommended by the Centers for Disease Control and Prevention.

Prior to assigning Consultant Personnel to perform In-Person Services, Consultant shall obtain proof that such Consultant Personnel have been fully vaccinated. Consultant shall retain such proof for the document retention period set forth in this Agreement.

Consultant shall grant medical or religious exemptions ("Exemptions") to Consultant Personnel as required by law. If Consultant wishes to assign Consultant Personnel with Exemptions to perform In-Person Services, Consultant shall require such Consultant Personnel to undergo weekly COVID-19 testing, with the full cost of testing to be borne by consultant. If Consultant Personnel test positive, they shall not be assigned to perform In-Person Services or, to the extent they have already been performing In-Person Services, shall be immediately removed from those assignments.

Furthermore, Consultant shall immediately notify City if Consultant Personnel performing In-Person Services (1) have tested positive for or have been diagnosed with COVID-19, (2) have been informed by a medical professional that they are likely to have COVID-19, or (3) meet the criteria for isolation under applicable government orders.

- 10. The existing **Section 13. ENTIRE AGREEMENT** and its **Subsections 13.1** through **13.3** are hereby renumbered to **Section 14. ENTIRE AGREEMENT** immediately followed by **Subsections 14.1** through **14.3**.
- 11. Section 14.3 Order of Precedence is hereby amended to read as follows:

14.3 Order of Precedence

This Agreement, and any exhibits, attachments, or documents incorporated herein by inclusion or by reference, constitutes the complete and entire Agreement between the City and the Consultant. In the event of any inconsistencies between the bodies of this Agreement and attachments, the order of precedence will be as follows:

- 1. This Agreement between the City of Los Angeles and Dixon Resources Unlimited and its Amendments
- 2. Attachment A Standard Provision for City Contracts (Rev. 9/22) [v.1]
- 3. RFQ for On-Call Professional Consultant Services
- 4. Consultant Proposal
- 12. Except as herein amended, all other terms and conditions of this Agreement shall remain unchanged and in full force and effect.
