PLUM COMMITTEE CONSIDERATION ITEMS FOR THE DOWNTOWN LOS ANGELES COMMUNITY PLAN AND THE NEW ZONING CODE; CF 22-0617; CASE NO. CPC-2017-432-CPU; CPC-2014-1582-CA; ENV-2017-433-EIR

The Downtown Community Plan and the New Zoning Code, (collectively, "Proposed Project"), were recommended for approval by the City Planning Commission (CPC) at its meeting on September 23rd, 2021. The Proposed Project included all of the following proposed ordinances:

- Chapter 1A Zoning Code Ordinance (Exhibit E);
- Downtown Community Plan Implementation Overlay (CPIO) District Ordinance (Exhibit D.1);
- Zone Change Map and Matrices (Exhibit D.2);
- Downtown Community Benefits Trust Fund Ordinance (Exhibit D.3);
- Downtown Community Benefits Fee Ordinance (Exhibit D.4);
- Downtown Affordable Housing Trust Fund Ordinance (Exhibit D.7);
- River Improvement Overlay (RIO) District Ordinance (Exhibit D.5);
- Greater Downtown Housing Incentive Ordinance (Exhibit D.6);
- Rescission of Downtown Design Guide and Bunker Hill Specific Plan Ordinance (Exhibit D.8);

b. Adopt the Downtown Community Plan policy document in the Council File, in the document dated October 18, 2022, and identified as, "Exhibit C.1 Community Plan Text," and

c. Adopt the General Plan Land Use Map for the Downtown Community Plan, inclusive of Symbols, Footnotes, and Corresponding Zone and Land Use Nomenclature located in the Council File in the document dated October 18, 2022, and identified as "Exhibit C.3 Proposed General Plan Land Use Map," and the General Plan Land Use Change Maps and Matrices located in the Council File in the document dated October 18, 2022, and identified as, "Exhibit C.4 General Plan Land Use Change Maps and Matrices;" and

d. Amend the Mobility Plan 2035 to reclassify selected streets and Enhanced Networks, as shown in the document in the Council File dated October 18, 2022, and identified as, "Exhibit C.7 Mobility Plan 2035 Amendments;" and

e. Amend the Citywide General Plan Framework Element, as shown in the Council File document dated October 18, 2022, and identified as, "Exhibit C.6 General Plan Framework Amendments."

5. **Adopt** the draft ordinance to amend the Zoning Map, located in the Council file document dated October 18, 2022, and identified as, "Exhibit D.2 Zone Change Map and Matrices", inclusive of optional modifications as shown in the Council File document dated September 29, 2022, and identified as, "Exhibit F.6 Director of Planning Memo to the PLUM Committee" and the Council File document dated March 30, 2023, and identified as, "Exhibit F.7 Director of Planning Supplemental Memo to the PLUM Committee."

6. **Request** the City Attorney to prepare and present the following ordinances for the City Council adoption, inclusive of all optional modifications as shown in the Council File document dated September 29, 2022 and identified as, "Exhibit F.6 Director of Planning Memo to the PLUM Committee," and all optional modifications as shown in the Council File document dated March 30, 2023, and identified as, "Exhibit F.7 Director of Planning Memo" [modifications applicable to ordinances in paragraphs a, b, and d below]:

a. The proposed Chapter 1A Zoning Code ordinance, located in the Council File document dated October 18, 2022, and identified as "Exhibit E CPC Recommendation Draft of new Zoning Code;" and the proposed Chapter 1A Zoning Code Maps, located in the Council File document dated October 18, 2022, and identified as "Exhibit E.2 Zoning Code Maps;" and

b. The proposed Downtown Community Plan Implementation Overlay (CPIO) District Ordinance, as shown in the Council File in the document dated December 7, 2022, and identified as "Revised Exhibit D.1 Downtown Community Plan Implementation Overlay (CPIO);" and
