SOURCE OF ACTIVITY:

On 01/21/23 at approximately 2205 hours, my partner, Officer Marsh #44208 (Passenger), and I, Officer Illsley #44195 (Driver), were assigned Southeast Division, unit 18X21-W3. We were in full L.A.P.D uniform, driving a marked black and white police vehicle, Shop# (81510). We conducted a check of our police vehicle at the start of watch and our emergency lights, forward facing red lights and sirens were in good working order at the time of our inspection. My partner and I were near 400 W. Century (Magic Carpet Inn Motel) conducting extra patrol. The aforementioned location has had an uptick in crime displaying numerous Grand Theft Auto's, Burglary from motor vehicles and Vandalisms. Numerous concerned citizens have requested PD conduct extra patrol due to the recent surge in crimes.

INVESTIGATION:

My partner Officer Marsh #44208 and I, Officer Illsley #44195 were driving eastbound on Century Bl. approaching Grand Ave. when we observed a 2018 Red Kia Sportage Lic plate ██████████ proceed eastbound on Century Bl from the entrance of the Magic Carpet Inn Motel. Kia Sportage's are one of the most common stolen vehicles due to the lack of security features. Due to the recent surge in crimes deriving from the vicinity of 400 W. Century and the vehicle description, my partner and I proceeded to obtain the license plate. As we traveled eastbound on Century Bl. my partner attempted to run the vehicle for wants and warrants via department resources (MDC). My partner and I observed the vehicle make a southbound turn onto Grand Ave from Century Bl. failing to signal and failing to come to a complete stop at a fresh red tri light. My partner and I veered behind the vehicle and proceeded to initiate a traffic stop to address the violations. The vehicle came back no wants/ no warrants.

As my partner and I approached the vehicle the suspect was seen sitting in the driver's seat. The suspect opened the vehicle door as I made my approach and I politely asked him to stay in the vehicle. As I began to speak with the suspect my partner and I observed major damage to the steering console and ignition area. The suspect made spontaneous statements stating it was not his vehicle and he was given \$50.00 to park the vehicle. I asked the suspect to step out of the vehicle and he was placed in handcuffs pending a stolen vehicle investigation. As the suspect began to tell me he did not have a driver's license my partner proceeded to request an additional unit to assist with our investigation.

We relayed to the suspect based on our training and experience and the spontaneous statements made it was our conclusion he was driving the vehicle without owner's consent and we would continue our investigation at Southeast station. 18A1 Officer Perez #42728 and Officer Bustamante #43628 arrived at scene and were able to contact the RO of the vehicle. The RO told Officer Perez she was on hold with the LAPD non-emergency line for the better half of the night. She stated she locked and secured her vehicle in the vicinity of Figueroa and 18th St. located in Downtown Los Angeles on 01/21/23 at approximately 0930.

After a short time, she returned to where she parked the vehicle at approximately 1800 hours and noticed it was missing. The RO stated she called local tow yards and after negative results she proceeded to call PD to report her vehicle missing. She was in possession of all vehicle keys and did not give anyone permission to drive her vehicle. She told Officers she was unaware who the suspect was.

Arrest:

Suspect 1 was arrested for 10851 (A) V.C. Suspect 1 was transported to Southeast Station for booking.

My partner admonished the suspect utilizing the LAPD's Field Officers Notebook while at 77th Jail and the following was stated.

You have the right to remain silent. Do you understand? Yes.

Anything you say may be used against you in court do you understand? Yes.

You have the right to the presence of an attorney before and during any questioning. Do you understand? Yes.

If you cannot afford an attorney, one will be appointed for you, free of charge, before any question, if you want. Do you understand? Yes.

The suspect stated an unknown person paid him to move the vehicle around the corner. When asked how he started the vehicle he replied he just turned the ignition with his hand. My partner asked if he knew the vehicle was stolen and he stated yes, he knew the vehicle was stolen but he was in dire need of money.



The Magic Carpet Motor Inn located at 400 W. Century Blvd has specific no trespass orders and posted signs saying such. The motel is known for sales of narcotics, prostitution, loitering, and multiple firearms have been recovered there as well. We conduct extra patrol in the motel parking lot in attempt to reduce violent crime.

Investigation:

We walked into the motel parking lot and immediately observed a male with a fanny pack across his chest, heavily weighted down and he was clutching it with his right hand close to his chest. Once he made eye contact with me he quickened his pace and began walking in the opposite direction of officers. We continued to monitor him. I watched him walk up to a vehicle parked near us (later identified as ██████████'s- Slvr/BMW/██████████) approached the driver's side door, he paused and looked in my direction. ██████████ then appeared to change his mind and walked over to another vehicle. He walked to the rear passenger side of another vehicle next to the back tire and bent down appearing to discard contraband. I immediately heard a loud metallic ping, and he quickly stood up and walked away from that vehicle.

Based on our observations, training and experience, we reasonably believed ██████████'s was concealing a firearm in his fanny pack across his chest in which he discarded. Upon observing the police, he walked over to a vehicle that did not belong to him, took it out of his fanny pack, tossed the firearm next to the vehicle's tire, and then attempted to distance himself away from it.

Officer Velez and Officer Martin immediately grabbed Person to detain him pending a weapons investigation. ██████████'s fanny pack that previously had a large bulge and was zipped up, was now unzipped and no longer weighted down with the bulge. I walked over to the vehicle where he had bent down next to and where I heard the loud metal ping, and in plain view there was a firearm that I recovered.

On March 4, 2023 at approx. 1728 hours my partner Officer Velez Serial No.41385, and I, Officer Molina Serial No.43054, were assigned to Southeast Division Gang Enforcement Detail deployed as unit 18G23-W6. We were dressed in full Police uniform and driving a marked black and white Police Hybrid vehicle when we were conducting extra patrol at the Magic Carpet Motel (400 W Century) due to ongoing trespass issues, narcotic sales and numerous firearm arrests. INC#230304002632.

Investigation

As we were driving east bound in the Magic Carpet Motel parking lot we observed a black BMW (Plate: [REDACTED]) with dark tinted windows illegally parked in the middle of the motel parking lot. As we approached the vehicle, the driver (witness: [REDACTED]) of the vehicle rolled the windows down. We smelled the strong odor of burnt marijuana emanating from the vehicle and observed thick smoking also emanating from the vehicle. As my partner made contact with Stamper, who had a marijuana blunt in his hand, I made contact with the front passenger ([REDACTED]) who was later identified as the suspect.

[REDACTED] appeared nervous and abruptly attempted to exit the vehicle. From outside of the vehicle I observed a purple fanny pack on the floor board of the vehicle in between [REDACTED] feet. Fanny packs are commonly used as firearm holsters because they hold firearms in place and make them easily accessible. [REDACTED]'s demeanor evaluated our suspicion that there was additional contraband in the vehicle. In an effort to conduct our investigation in the safest manner possible and per case law (Maryland V Wilson), we directed the vehicle occupants to exit the vehicle.

We conducted a narcotics and weapons investigation of the vehicle. During the investigation, I grabbed the purple fanny and observed a heavy "L" shape item weighing the fanny pack down. I opened the fanny pack and observed a loaded black semi-auto hand gun (item-1 through item-3) inside of the fanny pack. [REDACTED] and [REDACTED] were detained pending a weapons investigation.

At scene I rendered the firearm safe and observed the firearm to be in good working order.

We determined that [REDACTED] was in possession of the firearm because the fanny pack was in between his leg and he was the only person who had access to the firearm.

We transported [REDACTED] to Southeast station for a firearm violation.

Arrest

I read [REDACTED] his rights per LAPD Form 15.03.00. [REDACTED] invoked his Miranda rights.

At Southeast station, I conducted an inquiry into [REDACTED]'s criminal back ground. The results indicated that he did not have any felony convictions.

We placed [REDACTED] under arrest for 25400(a)1 PC Loaded Firearm Concealed in vehicle.

The Magic Carpet Motor Inn located at 400 W. Century Blvd has specific no trespass orders and posted signs saying such. The motel is known for sales of narcotics, prostitution, loitering, and multiple firearms have been recovered there as well. We conduct extra patrol in the motel parking lot in attempt to reduce violent crime.

Investigation:

As we drove into the parking lot of the hotel, we immediately observed a male (later identified as [REDACTED]) grab the right side of his waist band, blade his body in the opposite direction of us as if to conceal the right side of his body. He then quickly and abruptly walked away from a vehicle he was standing next to and walked to one of the hotel room doors. As he got to the hotel room door he began to what appeared to be nervously knocking on the door while simultaneously glancing back at officers.

As my partners and I approached [REDACTED], I observed a female come to the window of the hotel room he was knocking on and look at him with a confused look as if she didn't recognize him. I asked [REDACTED] if that was his room that he was knocking on and he didn't reply. I believed that wasn't his hotel room based on the occupants reaction and he was just knocking on the closest door in attempt to avoid police contact.

As officers were putting [REDACTED]'s hands behind his back to be detained, I observed a large bulge on the right side of his waist band where I previously observed him clutching his waist band. I immediately patted down that bulge, believing it was a weapon, and recognized it to a firearm. I lifted [REDACTED]'s shirt and removed the bulge and it was a small black semi-automatic firearm wrapped in a black beanie.

My partner's handcuffed [REDACTED] and he was taken into custody without incident.

I observed the firearm to be in good working order.




