The Brentwood Community Council ("BCC") is the broadest based Brentwood community organization, representing approximately 35,000 stakeholders of the 90049 community. BCC includes 13 homeowners associations, multi-family residential dwellers, business organizations, schools, religious groups, volunteer service groups, public safety and environmental organizations.

The BCC, at its monthly meeting held on April 12, 2023, considered the motion made by Councilmember Park on March 24, 2023, and voted to voice its support of Councilmember Park's efforts to encourage the development of best practices to ensure the safety of City personnel that may come into contact with synthetic opioids and to identify and understand protocols among the City's first responders for identifying and responding to new street drugs.
