REQUEST APPROVAL TO ACCEPT ADDITIONAL GRANT FUNDS (\$1,666,793) FROM THE CALIFORNIA DEPARTMENT OF AGING (CDA) UNDER AREA PLAN FISCAL YEAR 2022-2023 AMENDMENT 1, TO NEGOTIATE AND EXECUTE THE STANDARD AGREEMENT AREA PLAN 2223-25 AMENDMENT 1 (AP-2223-25-A1) WITH THE CDA, TO APPROVE AREA PLAN BUDGET AP-2223-25-A1, AND TO NEGOTIATE AND EXECUTE AMENDMENTS TO AGREEMENTS FOR OLDER AMERICANS ACT RELATED SERVICES.

The Los Angeles Department of Aging (LADOA) is requesting authority to accept \$1,666,793 in One-Time-Only (OTO) grant funding from the CDA, to approve the Area Plan Budget in AP-2223-25-A1, and to authorize the General Manager of LADOA or designee to execute the Standard Agreement AP-2223-25-A1. In addition, LADOA requests authority to execute amendments to agreements with senior service and family-caregiver program providers (as indicated in Attachment 1, Service Provider Allocation) by adding OTO funding for equipment, supplies, and baseline increases to the respective programs and services.

RECOMMENDATIONS

The General Manager of the LADOA requests that the City Council, subject to approval of the Mayor:

- 1. AUTHORIZE the General Manager, or designee, to accept the CDA Older American Act grant funds; to execute Standard Agreement for Area Plan 2223-25 Amendment 1, and any unilateral amendments to the subgrant agreement, subject to review and approval of the City Attorney as to form and legality, and in compliance with Los Angeles Administrative Code §14.8 et seq. (City grant regulations); and to authorize the Area Plan-2223-25 Amendment 1 budget;
- 2. AUTHORIZE the General Manager, or designee, to negotiate and amend the existing agreements with various service providers, subject to review by the City Attorney as to form and legality;
- 3. AUTHORIZE the Controller to:
 - a. Increase the appropriations within the Area Plan for the Aging Title III Fund Number 395 as follows:

BACKGROUND

LADOA received notification from CDA of One-Time-Only (OTO) funding for the purpose of increasing the levels of baseline service, replacing equipment, and purchasing supplies. In determining the allocation of these funds, LADOA reviewed actual service levels and expenditures to date of its contractors to ensure that the distribution of the additional funds were allocated on the basis of service needs and timeliness of expenditures. This allows us to maximize services in the areas of greatest needs.

AREA PLAN FY 2022-23 AMENDMENT 1 FOR FISCAL YEAR 2022-2023

The Area Plan-2223-25 Amendment 1 consists of mid-year adjustments from CDA with OTO awards totaling \$1,666,793, of which the Department proposes to award to its agencies for contracted services (\$1,523,585, about 91.4%) and to use for Departmental Office and Administrative Expenditures (\$143,208, about 8.6%). Table 1 summarizes the distribution amounts of the OTO funds per service program. Attachment 1, Service Provider Allocation provides details on the proposed distribution of funds per service provider per service program, as submitted to the CDA.
