For the candidates for the Office of Member of the Los Angeles City Council, Council District 6.

The attached certified results from the County of Los Angeles Registrar-Recorder/County Clerk are accompanied by a Resolution for your consideration, declaring the results of the Special Primary Election held on April 4, 2023.

Recommendation

That the City Council adopt the Resolution declaring the results of the City of Los Angeles Special Primary Election held on April 4, 2023.

Fiscal Impact Statement

While there is no fiscal impact of declaring the results for this Election, the total estimated cost for the County's conduct of the Primary Nominating Election is \$4M. The City Clerk expects to receive a bill from the County for the Special Primary Election in June 2023. Funds were set aside in the Unappropriated Balance. The City Clerk received \$150K to conduct candidate filing and nomination petition verification services.

A Special Runoff Election will be held on June 27, 2023 and the total estimated cost for the County's conduct is \$4M.
