Hi Hannah and Dan,

Marianne and I have discussed her comments and we are in agreement with the attached language (please note the minor change to Condition 10.d which Marianne has agreed to). Also attached is the Tree Preservation and Landscape Plan identifying in yellow, those trees to be retained. Finally, attached is a tree inventory prepared by Carlberg Associates that identifies trees on site and can therefore be used to cross reference the attached Tree Preservation and Landscape Plan.
