PUBLIC SAFETY COMMITTEE REPORT relative to the 2021-2024 Project Safe Neighborhoods (PSN) grant award.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. AUTHORIZE the Chief of Police, Los Angeles Police Department (LAPD), or designee, to:
  - a. Retroactively apply for and accept the grant award of \$266,568 for the 2021-2024 PSN grant, by and through the San Diego Association of Governments and the United States Attorney's Office, Central District of California, with funding from the Department of Justice, Bureau of Justice Assistance.
  - b. Negotiate and execute the grant agreement for the period of October 1, 2021 through September 30, 2024, subject to the review and approval of the City Attorney as to form.

# 2. AUTHORIZE LAPD to:

- a. Submit grant reimbursement requests to the grantor and deposit grant receipts in the LAPD Grant Fund No. 339/70.
- b. Spend up to the grant amount of \$266,568 in accordance with the grant award agreement.
- c. Prepare Controller instructions for any technical adjustments as necessary to implement Mayor and Council intentions, subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE the Controller to implement the instructions.

# 3. AUTHORIZE the Controller to:

- a. Establish a grant receivable and appropriate \$266,568 to appropriation account number to be determined, within Fund No. 339/70, for the receipt and disbursement of the 2021-2024 PSN grant funds.
- b. Increase appropriations by \$149,468 on an as-needed basis from the 2021-2024 PSN grant, Fund No. 339/70, account number to be determined, to Fund No. 100/70, Account No. 001092, Overtime Sworn.
- c. Increase appropriations by \$17,100 on an as-needed basis from the 2021-2024 PSN grant, Fund No. 339/70, account number to be determined, to Fund No. 339/70, account number to be determined, Related Costs.

# 4. INSTRUCT the City Clerk to place on the agenda for the first regular meeting on or after July 1, 2023, the following instruction:

That the City Council, subject to the approval of the Mayor, authorize the Controller to:

- a. Increase appropriations by \$89,734 on an as-needed basis from the 2021-2024 PSN grant, Fund No. 339/70, account number to be determined, to Fund No. 100/70, Account No. 001092, Overtime Sworn.
- b. Increase appropriations by \$10,266 on an as-needed basis from the 2021-2024 PSN grant, Fund No. 339/70, account number to be determined, to Fund No. 339/70, account number to be determined, Related Costs.

<u>Fiscal Impact Statement</u>: The CAO reports that approval of the recommendations within this report will allow for the expenditure of the 2021-2024 PSN grant award totaling \$266,568. The grant will provide overtime funding for sworn personnel and funding for related costs. No matching funds are required for this grant. There is no impact to the General Fund as a result of these recommendations.

<u>Financial Policies Statement</u>: The CAO reports that the recommendations provided in this report are in compliance with the City's Financial Policies in that one-time grant funding will be utilized for one-time grant-eligible program expenditures.
