AD HOC COMMITTEE ON THE 2028 OLYMPICS AND PARALYMPIC GAMES REPORT relative to benchmarks and commitments for working groups and other priorities identified in the Games Agreement for the Olympic and Paralympic Games 2028 (LA28).

Recommendation for Council action:

NOTE and FILE the January 17, 2023 joint City Administrative Officer (CAO)/Chief Legislative Analyst (CLA) and June 30, 2022 CAO reports, inasmuch as these reports are for information only and no Council action is required.

## Summary:

On April 25, 2023, your Committee considered January 17, 2023 joint CAO/CLA and June 30, 2022 CAO reports relative to benchmarks and commitments for working groups and other priorities identified in the Games Agreement for the LA28. According to the CAO/CLA, on April 27, 2022, City Council met to consider an April 7, 2022 joint CAO/CLA report relative to benchmarks and commitments for working groups and other priorities identified in the 2028 Games Agreement (Contract No. C-139679) with LA28. At that meeting, Council instructed the CAO and CLA to present a report by June 30, 2022 on the implementation of working groups, planning groups, and other legacy elements as outlined in the Benchmarks Report, with emphasis on representation from the Native American community and the Los Angeles County Federation of Labor.

Also, the CAO and CLA were instructed to monitor and report every six months on the implementation of the working groups, planning groups, and other legacy elements as outlined in the Benchmarks Report, beginning on October 30, 2022. The January 17, 2023 joint report serves as the first of these biannual reports. LA28 submitted a report dated October 18, 2022 (Exhibit A to the January 17, 2023 joint CAO/CLA report) to provide a status report on the implementation of the working groups. LA28 states that it has developed a four phase program to implement the Working Group Program. As an update to Exhibit A, LA28 notified the City on December 1, 2022 that it met the Phase 2 benchmark by identifying the organizations that will comprise the membership of each working group and invited 30 organizations to join one of the three working groups. LA28 is currently awaiting confirmations of participation from the invited organizations and will continue to evaluate additional member submissions. After further consideration and having provided an opportunity for public comment, the Committee moved to note and file the two reports as detailed above. This matter is now submitted to Council for its consideration.
