2. That the Board TRANSMIT to the Mayor and City Council the Supplemental Police Account Expenditure Plan 34 (SPA 34).


**DISCUSSION**

The Adopted Budget for FY 2020-21 included a Department of Justice and Treasury Department allocation of \$1.5 million for SPA 34. These funds are for discretionary use by the Department; however, expenditures are contingent on the development and approval of an expenditure plan detailing use of these funds.

The attached fact sheet summarizes the anticipated expenditure of funds allocated to SPA 34; and Addenda I through III detail the line items within each schedule of expenses. Funding for miscellaneous operational expense, equipment, and training expense from SPA 34 is intended to supplement funding approved in SPA 32 and SPA 33 to support ongoing operations.

**SUPPLEMENTAL POLICE ACCOUNT  
EXPENDITURE PLAN 34 (SPA 34)  
April 10, 2023**

**The Los Angeles Administrative Code Section 5.115 provides for the Forfeited Assets Trust Fund, and within this fund, the Supplemental Police Account (SPA). The SPA is an annual allocation of \$1.5 million to the Los Angeles Police Department (Department) with the expenditure plan approved by the Mayor and City Council. The Adopted Budget for Fiscal Year 2020-21 included an allocation of Department of Justice and Treasury Department funds totaling \$1.5 million for SPA.**

Actual disbursement of these funds can occur only after an expenditure plan is submitted and approved by the Mayor and City Council. Fiscal Group prepares the annual expenditure plan based upon operational needs associated with miscellaneous operational expenses, equipment, and training expenses.

The proposed expenditure plan for SPA 34 is divided into three categories with the following proposed allocations:

I.	Miscellaneous Operational Expense	\$ 615,271
II.	Equipment	\$ 166,139
III.	Travel & Training	\$ 718,590
	<b>TOTAL</b>	<b>\$ 1,500,000</b>

Following is the summary of information on the anticipated expenditures in each category.

**MISCELLANEOUS OPERATIONAL EXPENSES - \$615,271 (Addendum I)**

Funding for miscellaneous operating expenses will provide continuous support to a variety of law enforcement activities as required.

Funding in the amount of **\$63,990** is being provided to **Major Crimes Division (MCD)** for telecommunications expenses and vehicle leases and rentals.

Funding in the amount of **\$74,501** is being provided to **Commercial Crimes Division (CCD)** for software service renewals.

Funding in the amount of **\$19,919** is being provided to **Robbery Homicide Division (RHD)** for GPS tracking services, cell phone service, and other telecommunications and miscellaneous expenses.

Funding in the amount of **\$358,257** is being provided to **Gang and Narcotics Division (GND)** for bucket truck leases, veterinarian services, paid informants, and other telecommunications and miscellaneous expenses.

Funding in the amount of **\$92,604** is being provided to **Special Operations Division (SOD)** for vehicle rentals, air and cellular service, a tracking service system, an audio recording service, and other miscellaneous expenses.

Funding in the amount of **\$5,000** is being provided to **Emergency Services Division (ESD)** for military property acquisition shipping costs.

Funding in the amount of **\$1,000** is also being **reserved for unforeseen miscellaneous expenses** and increases in telecommunications expenditures.

#### **EQUIPMENT - \$166,139 (Addendum II)**

The expenditure plan for SPA 34 reflects the need for safety and support equipment required to bolster law enforcement activities in the City of Los Angeles, such as specialized technology equipment, surveillance equipment, investigative tools, and canine replacement.

Funding in the amount of **\$38,280** is being provided to **MCD** for investigative equipment for operations.

Funding in the amount of **\$17,750** is being provided to **CCD** for computer hardware equipment parts and replacements.

Funding in the amount of **\$1,342** is being provided to **RHD** for a tracking device for operations.

Funding in the amount of **\$83,335** is being provided to **GND** for canine replacements including kennels and other miscellaneous equipment, camera equipment, ammunition, and range supplies.

Funding in the amount of **\$24,432** is being provided to **SOD** for the purchase of ammunition, range supplies, and other investigative equipment for operations.

Funding in the amount of **\$1,000** is also being **reserved for unforeseen miscellaneous expenses** and increases in expenditures.

#### **TRAVEL AND TRAINING - \$718,590 (Addendum III)**

Supplemental Police Account 34 includes funding for work-related travel and training for the following Department entities:

- **\$52,705** for CCD
- **\$51,320** for GND
- **\$10,950** for SOD
- **\$10,000** for ESD
- **\$16,000** for MCD

Funding in the amount of **\$520,615** for Air Support Division is for simulator and flight safety training, all of which have been proven to aid in the overall life and safe operation of the aircraft.

Funding in the amount of **\$56,000** is for the Chief of Police's (COP's) discretionary travel budget. This includes up to **\$10,000** for the Department's participation in the National Police Week. Discretionary travel funds are provided for the COP with the intent of providing a funding source to support the Chief's efforts in promoting the professional image and reputation of the Department and to further the Department's role in professional law enforcement organizations.

Funding in the amount of **\$1,000** is also being reserved for unforeseen miscellaneous expenses and increases in expenditures.
