SUMMARY

The Los Angeles Fire Department Foundation (LAFDF) has graciously donated 15 medium and 5 small Aventure Ebikes and accompanying equipment to the Emergency Services Bureau. The Ebikes will be deployed to the Los Angeles Fire Department's Cycle Team, led by Captain Chad Rolish. The Cycle Team will utilize the donated equipment during certain deployments and department events which will be extremely beneficial. During large-scale events, members will be able to respond to patients in a timely manner and provide definitive care and be able to better navigate challenging terrain. All members will be required to be certified in Ebikes through the current International Police Mountain Bike Association. The value of this donation is estimated at \$31,684.43.

RECOMMENDATIONS

That the Board:

1. Receive this report for the In-Kind Donation by the Los Angeles Fire Department Foundation for the items listed above, valued at \$31,684.43 to the Los Angeles Fire Department.
2. Request the Commission Executive Assistant to transmit this report to the Mayor's Office in accordance with Executive Directive No. 3 and to City Council in accordance with the Los Angeles Administrative Code, Ordinance 15514, Article 12, Section 5.111.4, for consideration and approval.

FISCAL IMPACT

There is no fiscal impact on the Department's budget from the acceptance of this donation. Donations provide the necessary items to meet the needs of the respective fire stations or administration sections. Replacement or repair of items meeting City

specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.

The Los Angeles Fire Department benefits tremendously from gracious donations and support provided by the LAFD Foundation. The LAFD acknowledges the LAFDF for its generosity.
