In this case, Councilmember Cedillo, specifically lobbied by a certain paid City Hall lobbyist on behalf of the developer that owns this historic place, and who wants to tear it down, had held up the nomination for an unacceptable period of time. (Notice the Council File Number was opened in 2020 - three years ago!) Now, with the election of Eunisses Hernandez, one would think that a more progressive candidate would reject the solicitations from paid lobbyists for developers -- or at least that's what many heard during the campaign for this office. Just last week, the management of the Dodgers stepped on the political third rail of politics after caving to special interest lobbying of the Catholic Church to disinvite the Sisters of Perpetual Indulgence from the Dodger's Gay Pride Night. This action was taken in ignorance of the substantial contribution of the Sisters, despite their unconventional methodology to get media attention to their cause. Well, how did that turn out for the Dodgers? A public relations disaster. A very public humiliation, followed by a reversal of the decision. Councilmember Hernandez should take a cue from the Dodgers. If she caves in to the greed and short term profit motive of the developer and those who are paid by that developer to cut some kind of deal in a back room, it will be seen and cited over and over in the next election as the first sign that the last election really did not matter. A "progressive" candidate should be demonstrating support of the communities who elected her -- not silently reducing the significant societal contributions of Morris Kight and his place on 4th Street to a little plaque or sign. How insulting to the birthplace of so many things that are fundamental in LBGT+ civil rights today! Comments for Public Posting: Dear Los Angeles City Councilmembers, Please vote yes to make Morris Kight's 4th Street Residence an Historic-Cultural Monument at the June 6th hearing. Everyone I know is either scared, depressed or angry (or all of the above), especially me and my LGBTQ family and friends. Denying HCM designation to Morris Kight's 4th Street house would not only be wrong (because the house has already been judged and found historic) but it will also send the wrong message (Los Angeles must stay vigilant against LGBTQ bias). At least 417 anti-LGBTQ bills have been introduced in state legislatures across the United States since the start of 2023 — a new record, according to American Civil Liberties Union data as of April 3. That's already more than twice the number of such bills introduced all of last year. And 24 bills that restrict LGBTQ rights have passed in 11 states. Morris Kight fought for all of us. His home at 1822 4th Street is the birthplace of the modern LGBTQ civil rights movement. Kight's home was a gay community services center, an outreach center and a meeting place for grassroots activists, actions and causes. Kight co-founded the Gay Liberation Front/Los Angeles chapter (1969) and held their meetings at his 4th Street house; one of their actions was to force the American Psychiatric Association to stop listing homosexuality as a mental illness. Kight personally ran the first ever LGBT crisis hotline. The first ever gay pride parade was conceived and planned at 1822 4th Street. And the first ever Gay Community Services Center (1971) was born from the services center at Kight's home (and would grow into the country's largest LGBT services center). I urge you to do the right thing. Please vote yes to make Morris Kight Residence 1822 W. 4th Street an Historical Cultural Monument at the June 6th hearing. Sincerely,
