## MOU AMENDMENT NO. 3 CONFIDENTIAL ATTORNEYS UNIT (MOU 31)

The International Union of Operating Engineers, Local 501 and the City of Los Angeles have reached agreement on the addition of Juneteenth as a paid City Holiday. The MOU is hereby amended as follows.

The following subsections of Article 16 – Holidays are **amended** as follows:

### ARTICLE 16 HOLIDAYS

- A. The following days shall be treated as holidays:
  - 1. New Year's Day
  - 2. Martin Luther King's Birthday (the third Monday in January)
  - 3. Presidents' Day (the third Monday in February)
  - 4. Cesar E. Chavez Birthday (the last Monday in March)
  - 5. Memorial Day (the last Monday in May)
  - 6. <u>Juneteenth (June 19)</u>
  - **7.** Independence Day (July 4)
  - **8.** Labor Day (the first Monday in September)
  - **9.** Indigenous Peoples Day (the second Monday in October)
  - **10.** Veteran's Day (November 11)
  - **11.** Thanksgiving Day (the fourth Thursday in November)
  - **12.** The Friday after Thanksgiving Day
  - **13.** Christmas Day
  - **14.** Any day or portion thereof declared to be a holiday by proclamation of the Mayor, and the concurrence of the City Council by resolution.
  - **15.** Two unspecified holidays.
- B. When any holiday from 1 through <u>13</u> above falls on a Sunday, it shall be observed on the following Monday.
- C. When any holiday from 1 through <u>13</u> above falls on a Saturday, it shall be observed on the preceding Friday.

All other provisions of Article 16 remain unchanged.

## MOU AMENDMENT NO. 3 CONFIDENTIAL ATTORNEYS UNIT (MOU 31)

Except for the amendment specified herein, Articles and/or provisions of the 2019-2023 MOU No. 31 shall remain in full force and effect during the term of the MOU.
