Recommendation

The Information Technology Agency (ITA) has reviewed the application of the 940 East 2nd Street Owners Association private line telecommunications franchise, and recommends approval of said application request. Because private line franchises are effectuated by ordinance, ITA also recommends Council to request that the City Attorney prepare and present a draft ordinance to City Council, with a ten-year term, allowing for this franchise.

Background

A private line telecommunications facility is an encroachment permit that provides for the interconnection between two points in the public right-of-way, utilized solely for signal transmission and not to serve any customer within the City.

The 940 East 2nd Street Owners Association is the homeowners association for the building at this address. The building is located in the Los Angeles Historic Arts District and contains 38 live/work lofts in the Arts District.

The 940 East 2nd Street Owners Association is requesting that the City grant a franchise for the use of conduit in the City's public rights-of-way at 940 East 2nd Street from the existing call box and the 3rd Street side of the property, onto the public right-of-way and back onto the property.

940 East 2nd Street Owners Association is requesting a private line franchise be granted for 10 years.
