TRANSPORTATION COMMITTEE REPORT and RESOLUTION relative to the prohibition of the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height during the hours of 2:00 am and 6:00 am along various street segments in Council District 11 (CD 11).

Recommendations for Council action, pursuant to Resolution (Park – Lee):

- 1. PROHIBIT, pursuant to the Los Angeles Municipal Code (LAMC) Section 80.69.4, the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 am and 6:00 am along the following street segments:
  - a. Both sides of Westminster Avenue between Federal Avenue and McLaughlin Avenue
  - b. Both sides of Glencoe Avenue between Mindanao Way and Alla Road
  - c. Both sides of Ocean Park Boulevard between Bundy Drive and Centinela Avenue
  - d. Both sides of Westgate Avenue between Missouri Avenue and Nebraska Avenue
  - e. Pershing Drive between Talbert Street and Manitoba Street
  - f. Alvern Circle between La Tijera Boulevard and Flight Avenue
- 2. DIRECT the Los Angeles Department of Transportation (LADOT), upon the adoption of this Resolution, to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed at the above location.
- 3. AUTHORIZE the LADOT to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

<u>Fiscal Impact Statement</u>: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

## Summary:

On June 14, 2023, your Committee considered a Resolution (Park - Lee) relative to the prohibition of oversized vehicles parking along various street segments in CD 11. According to the Resolution, there is an increased problem with oversized vehicles

parking along several street segments where large vehicles are often parked overnight and constrict travel lanes, thereby creating dangerous situations. Pursuant to LAMC Section 80.69.4, and California Vehicle Code Section 22507, it is proposed that the parking of vehicles that are in excess of 22 feet in length or over 7 feet in height, during the hours of 2:00 am and 6:00 am, be prohibited along the street segments as detailed in Recommendation No. 1. After consideration and having provided an opportunity for public comment, the Committee moved to approve the Resolution. This matter is now submitted to Council for its consideration.
