**Comments for Public Posting:** I live in Los Feliz and the Los Feliz Improvement Association (LFIA) wants me to share all reasons why the zoo should not be allowed to expand using pre-written talking points that oppose it. Candidly, I have a different opinion and am IN FAVOR and SUPPORT THE DEVELOPMENT of an expanded and greater Los Angeles Zoo. With that said, while I understand that there are differing viewpoints on this matter, I believe it is important to consider a balanced perspective. Here are the talking points I was asked to use to oppose the zoo's expansion, but I have a different perspective on each of them:  
~Excavation of Condor Canyon: Opponents argue that excavating a 60-foot deep Condor Canyon through a significant geological feature is destructive and expensive, and they fear it will radically change Griffith Park aesthetically and ecologically. While I recognize these concerns, it is crucial to understand that the zoo's expansion aims to create improved habitats for the animals and provide a better experience for visitors. By engaging environmental experts and adopting responsible excavation practices, we can minimize the environmental impact and ensure the preservation of the park's beauty and ecological integrity.  
~Placement of the California Visitor Center: Some express concerns about the placement of the new event space, the California Visitor Center, on top of a ridgeline, arguing that it will destroy the natural park topography. While this is a valid concern, we should consider the potential benefits that a well-designed visitor center can bring. By carefully considering the location and integrating the center into the surrounding landscape, it is possible to create a structure that respects the natural topography and offers educational opportunities for visitors. Griffith Park Observatory as well as the Hollywood Sign are examples of structures that work seamlessly in the park and the natural surroundings and can be seen from much of the Los Angeles basin and in fact are considered hallmark's of the Park's topography -- are we going to get rid of them?  
~Development of Native Habitat: Opponents argue that the 16 acres of native habitat within the expansion area should not be developed due to the presence of rare and sensitive plants and wildlife. Additionally, they highlight the existence of 26 City Protected Trees/Shrubs. While I appreciate the importance of preserving native habitats, it is essential to note that the zoo can

work closely with environmental experts to minimize the impact on these areas. By implementing thorough environmental assessments and adopting mitigation measures, we can ensure the protection of these species and their habitats while still allowing for the zoo's responsible growth. It is crucial to approach the enlargement of the Los Angeles Zoo with an open mind and consider multiple perspectives. By addressing concerns regarding excavation, placement, and native habitat development, we can find common ground and develop a plan that prioritizes conservation, education, and community engagement. Let us encourage constructive dialogue between the zoo management, environmental organizations, and concerned community members. Together, we can strive for a well-balanced approach that safeguards the park's beauty, respects the ecological integrity, and supports the important conservation efforts of the Los Angeles Zoo. **Comments for Public Posting:** I would like to comment on the zoo expansion plans, and in particular the proposed visitors center. I use this portion of the park every weekend (I use the trail that circumnavigates the ridge above the zoo, for running, hiking & birdwatching). In a city with too few parks, Griffith park is a rare treasure of undeveloped land. Once the land is developed, particularly with buildings, it is irreversible, and it feels like an encroachment on what makes Griffith Park so special—chipping away at a precious resource. The building in particular, positioned on a ridge, is super upsetting. There are models for zoos that integrate with the landscape—I think of the Living Desert museum in the Palm Springs area, which remains a great place to birdwatch local birds—so I'm not fundamentally against an expansion, particularly if it is done sensitively to the environment & the existing ecosystem, but the visitors center is an unnecessary overreach & demonstrates a lack of sensitivity to a local treasure.
