Subject: Bi-weekly Report - Council File No. 23-0300 – Declaration of Local Emergency/Los Angeles Aqueduct

In response to the above-referenced Council Motion, the Los Angeles Department of Water and Power (LADWP) is taking immediate action to manage water flow into Owens Lake and repair dust-control measures following a local emergency, as declared by Mayor Karen Bass on March 14, 2023.

The Los Angeles City Council (City Council) resolved to temporarily waive competitive bidding restrictions for LADWP until April 21, 2023, so that construction contracts, supplies, and equipment could be procured quickly. Due to the continued state of emergency, the City Council took action in their meetings on Friday, April 21, 2023; Tuesday, May 16, 2023; Wednesday, June 7, 2023; and Wednesday, July 5, 2023, to extend the state of emergency by an additional 30 days. Snowmelt runoff will continue to increase through the summer as ambient temperatures rise. While LADWP continues to do everything it can to prepare for the excess runoff, the full magnitude of impacts is unknown at this time and will not be known until the summer is over. Therefore, it is necessary to continue the declared state of local emergency for another 30 days, as defined by LAAC, Section 8.21, et seq.

LADWP must report to the City Council every two weeks on why competitive proposals or bidding were to be impractical. This is LADWP's eighth bi-weekly update.

## Bi-Weekly General Updates – July 12, 2023:

- Runoff continues to increase through the summer. Temperatures have increased, raising the risk of increased runoff.
- An emergency contract with Rain for Rent allowed the installation of siphons at Tinemaha Dam to protect the dam and spillway. Fourteen siphons were successfully

installed. Each siphon is capable of carrying up to 500 cubic feet per second of water over the dam.

- LADWP's Northern District Engineering Division obtained approval from the Division of Safety of Dams to raise the spillway elevation at Long Valley Dam, providing an additional 18,000 acre-feet of storage to avoid spilling and impacting sensitive habitats downstream of the dam.
- LADWP is working to award a sole source contract (IFB No. 1397770) for a Precast Concrete Box Culvert Forming System. This will enable LADWP to expeditiously fabricate and replace box culverts that may be damaged by extreme runoff water. Box culverts are currently limited in supply and difficult to procure due to high demand and fabrication lead time.
- Conservative estimates show that Owens Lake will receive a minimum of 140,000 acre-feet of runoff through August.
- Under awarded Contract No. 8008 for emergency construction services, Sully Miller Contracting Company (SMC) installed approximately 58,000 linear feet of access road armoring (11 miles), which is 78 percent of the required 14 miles. SMC raised the elevation on approximately four miles of access roads and completed the installation of 15,000 sandbags, 100 k-rails, and 35,000 square feet of plastic liner for the protection of critical assets at Owens Lake.
