AUTHORITY TO ACCEPT STATE SPECIFIED GRANT AGREEMENT NUMBER D2218007, IN THE AMOUNT OF \$7,000,000, FROM THE STATE WATER RESOURCES CONTROL BOARD FOR THE HOLLENBECK PARK LAKE REHABILITATION AND STORMWATER MANAGEMENT PROJECT

RECOMMENDATION

- 1. Pursuant to the approved Council File No. 22-1150, which instructs the Director and General Manager of LA Sanitation and Environment (LASAN) or designee, to report back and request authority to accept the grant award and confirm that there is no additional General Fund fiscal impact:
 - a. Approve and forward this report, with its transmittals, to the Mayor and City Council with the recommendation that the City Council, subject to concurrence of the Mayor, authorize the Director and General Manager of LASAN, or designee, to accept grant agreement number D2218007 and submit all documents, including, but not limited to, agreements, amendments, and payment requests etc., subject to the approval of the City Attorney as to form, which may be necessary to secure state specified grant funds for the Hollenbeck Park Lake Rehabilitation and Stormwater Management Project from the State Water Resources Control Board (SWRCB).
 - b. Request that the City Council, subject to concurrence of the Mayor, waive the requirement to "establish a separate interest bearing fund specified in CF No. 22-1150 since LASAN is the direct grantee and as this is not a pass-through grant.

DISCUSSION

BACKGROUND

The Hollenbeck Park Lake Rehabilitation Project is a proposed project led by LA Sanitation and Environment (LASAN) in partnership with the Department of Recreation and Parks (RAP) to implement a regional multi-benefit stormwater project in Hollenbeck Park and the adjacent neighborhood. This project aims to improve water quality in the Boyle Heights neighborhood, Hollenbeck Park Lake (Lake), and the Upper Los Angeles River Watershed (ULAR).

This project proposes multi-benefit components consisting of stormwater diversions, capture and treatment structures, and green street network components. Proposed green street elements within the watershed will improve air quality and provide aesthetically appealing green spaces for residents to enjoy year-round. The addition of about 50 trees in the park and the surrounding area will provide shade, reduce heat island effect, and cool the area for pedestrians and people engaged in active recreation. The stormwater capture structures will reduce flooding, especially during significant storm events. Constructed wetlands and recirculation will provide water quality and community benefits. Overall, these improvements will bring newer, fresher, and greener revitalization to this neighborhood without displacing residents or businesses.

As authorized by CF 22-1150 on March 30, 2023, LASAN submitted an application to the State Water Resources Control Board - State Specified Grant Number D2218007 in the amount of \$7,000,000. As a budgeted item in the 22-23 Enacted California State Budget, a grant agreement with the State to secure these funds must be executed prior to the close of the State Fiscal Year.

PROJECT REVIEW BY COMMITTEE/DIRECTOR (PRC/PRD) APPROVAL

The Hollenbeck Park Lake Rehabilitation and Stormwater Management Project (TOS SN-53) was approved by PRD to develop a feasibility report (SCW Regional Round 4 application). The Project was approved by the Upper LA River Watershed Advisory Stakeholder Committee (WASC) and the Regional Oversight Committee (ROC) for inclusion into the FY 2023-24 Stormwater Investment Plan (SIP). PRC is being concurrently reviewed with the Board Report to open a project specific work order for the Project.

STATUS OF FINANCING

There is no impact to the General Fund. Reimbursements from the State Water Resources Control Board (SWRCB) will be deposited into Fund 511, Stormwater Pollution Abatement Fund, Department 50, Department Revenue Source Code 336100 (Other State Grants-General).

Funds and appropriations for future fiscal years are not yet identified and existing appropriations may change based on available cash balances. Therefore, funds and appropriations will be determined by the Director and General Manager of LASAN or designee.
