Comments for Public Posting: Since this committee was formed in 2016 to address Homelessness and Poverty, the homelessness crisis has only gotten worse, which is reflected in the most recent LAHSA homeless count. Masses of people continue to die in the streets (#3aDayinLA), while this committee passes ordinances to criminalize unhoused people (LAMC 56.11, 85.02, Bridge Shelter enforcement zones, attempts to revamp 41.18) This committee has NO CREDIBILITY in addressing this crisis. On the contrary, its actions have only contributed to it. Promises of Prop HHH and Project Roomkey have fallen woefully short while you continue to push bridge shelters with expensive+harmful criminalization zones. This committee must be abolished in favor of one suggested in Bonin's motion, led by people who are currently or recently unhoused. The first step towards this is immediately removing Committee Chair Mitch O'Farrell from this committee as he holds in-person meetings with housed constituents regarding their complaints about having to see encampments while completely ignoring the voices of his constituents who are actually living and dying in encampments.
