My office represents the Appellants in the above matter. Appellants respectfully request the September 5, 2023, appeal hearing be continued to the October 3, 2023, PLUM meeting or a suitable date thereafter.

I have spoken with Emma Howard, the Planning and Community Development Director for Council District (CD) 13 and relayed that the Appellants will propose a modification of the underlying Zoning Administrator decision that would include permanently ceasing all alcohol sales subject to certain other conditions being modified. Ms. Howard stated that CD 13 supports the continuance of this item so that the Appellants have time to reach out and obtain feedback from neighborhood stakeholders, the Neighborhood Council, and the LAPD.
