In a report to Council dated February 9, 2018, LADOT requests approval of a proposed amendment to contract C-124676 to change the contractor's name from Xerox State and Local Solutions, Inc. (Xerox) to Conduent State and Local Solutions, Inc. Conduent (formerly Xerox) informed LADOT that as of January 1, 2017, the business process services of the Xerox Corporation is now part of and is being conducted under the new name Conduent, Inc. LADOT states that all other contract provisions remain unchanged.

At its meeting held February 28, 2018, the Transportation Committee recommended that Council approve LADOT's request.
